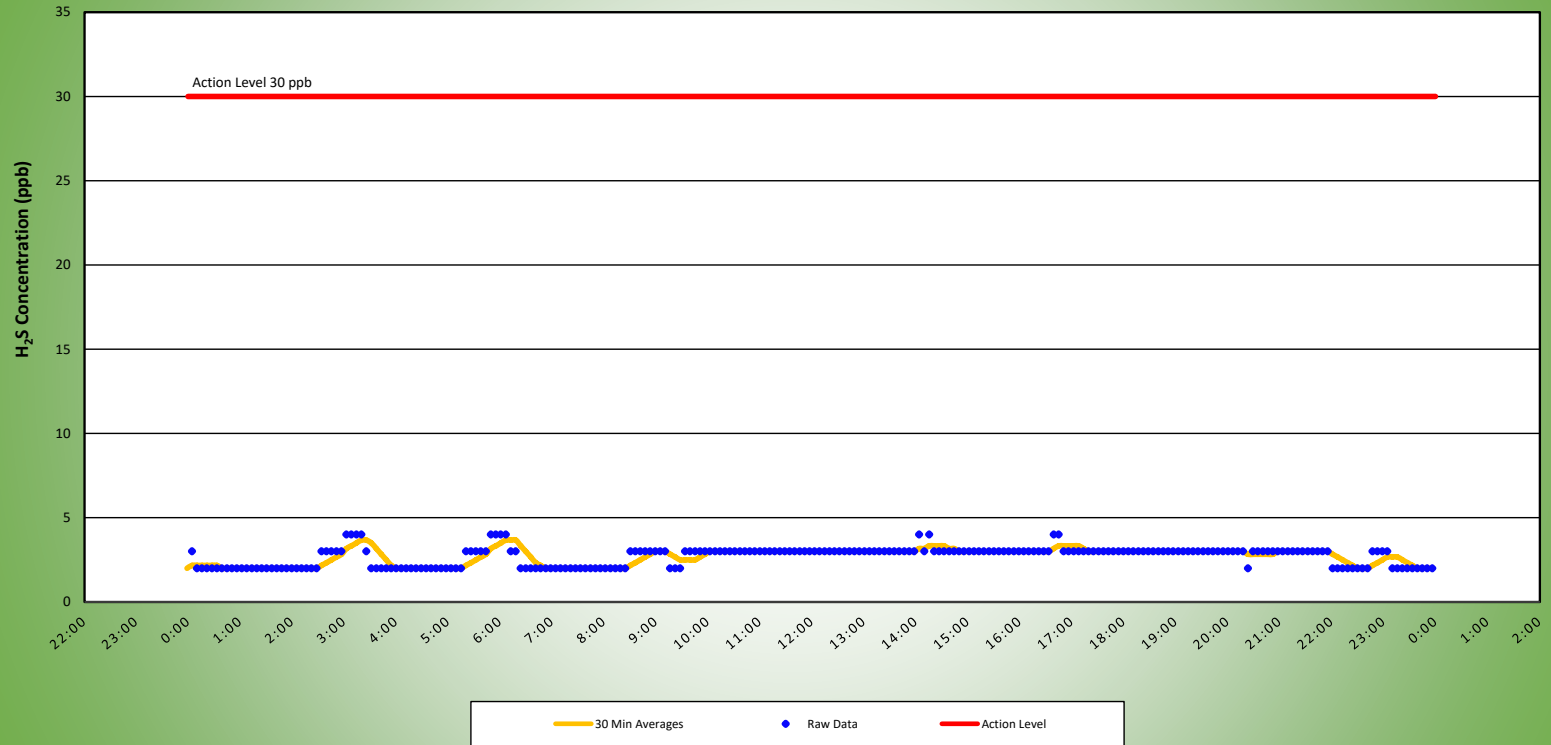
# MS1 H2S MONITORING RESULTS - 02/27/22

NON-PROPERTY LINE MONITOR



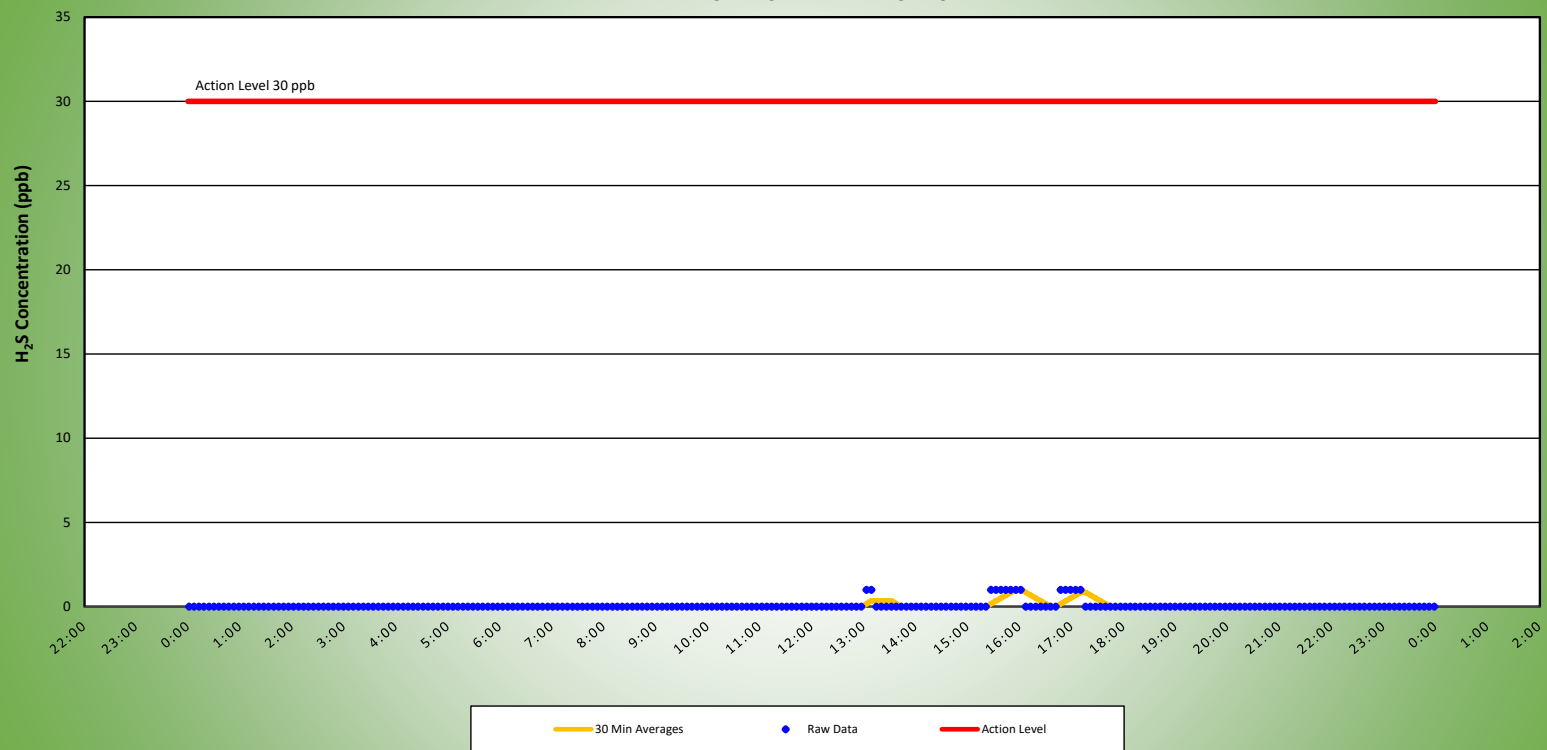
# MS2 H2S MONITORING RESULTS - 02/27/22

NON-PROPERTY LINE MONITOR



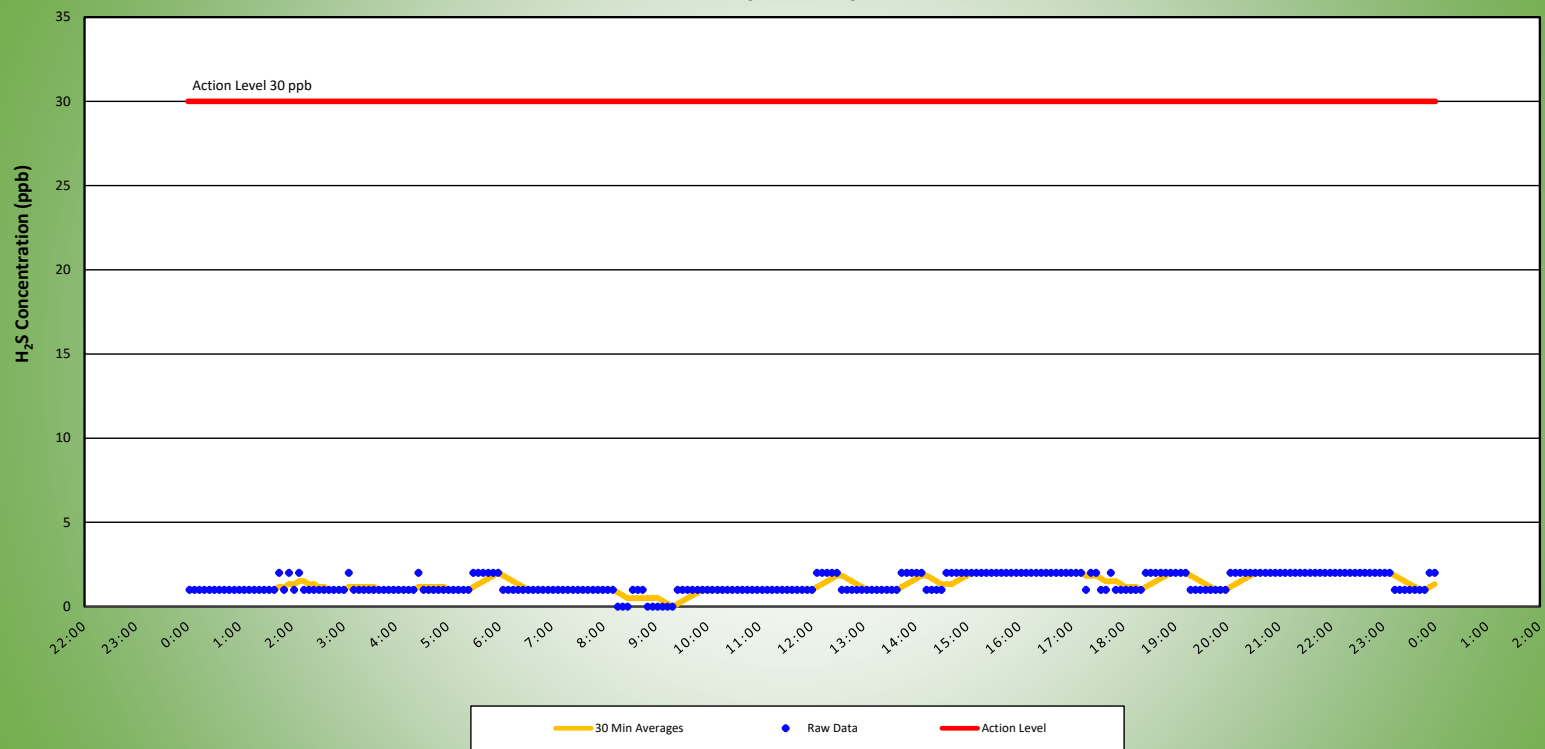

NON-PROPERTY LINE MONITOR



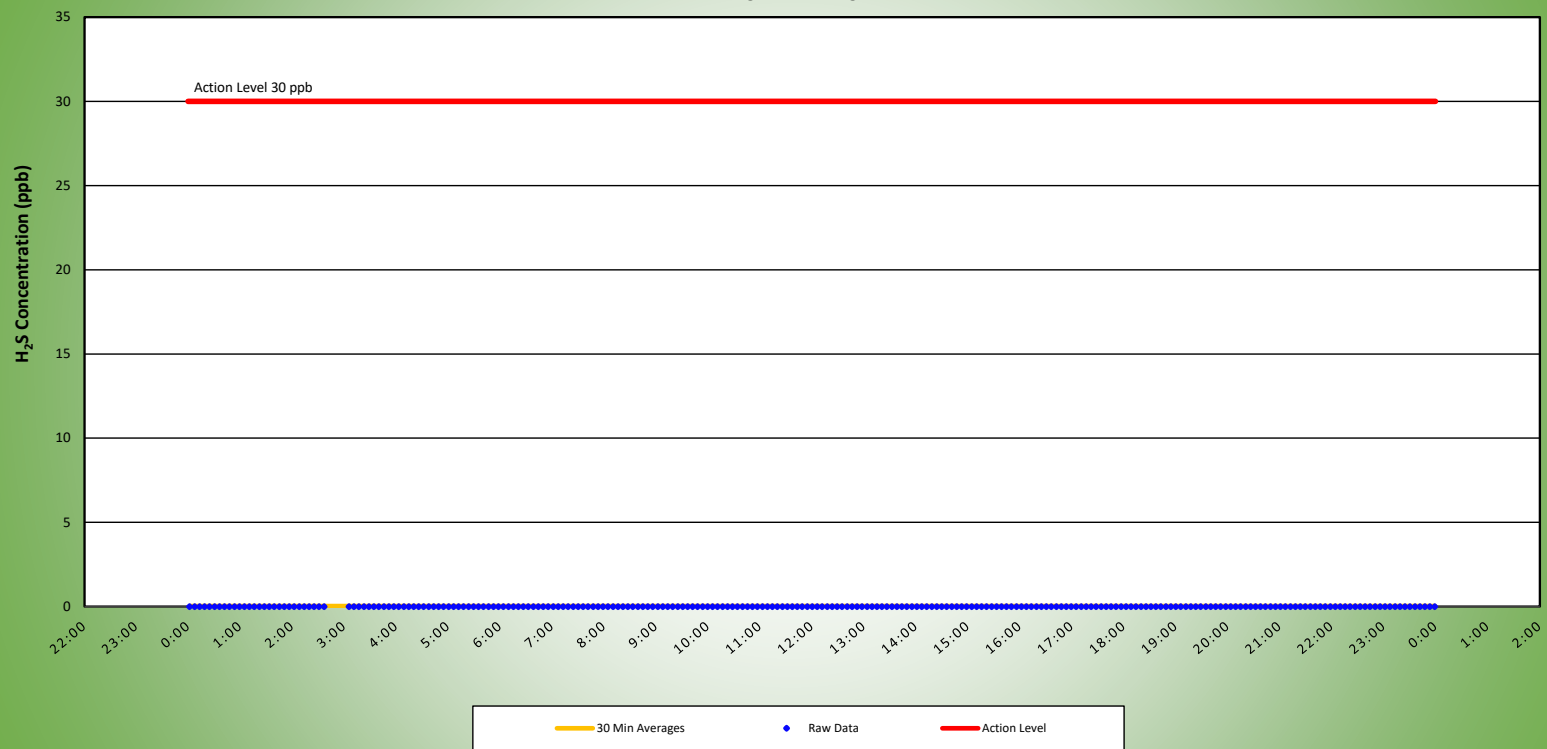

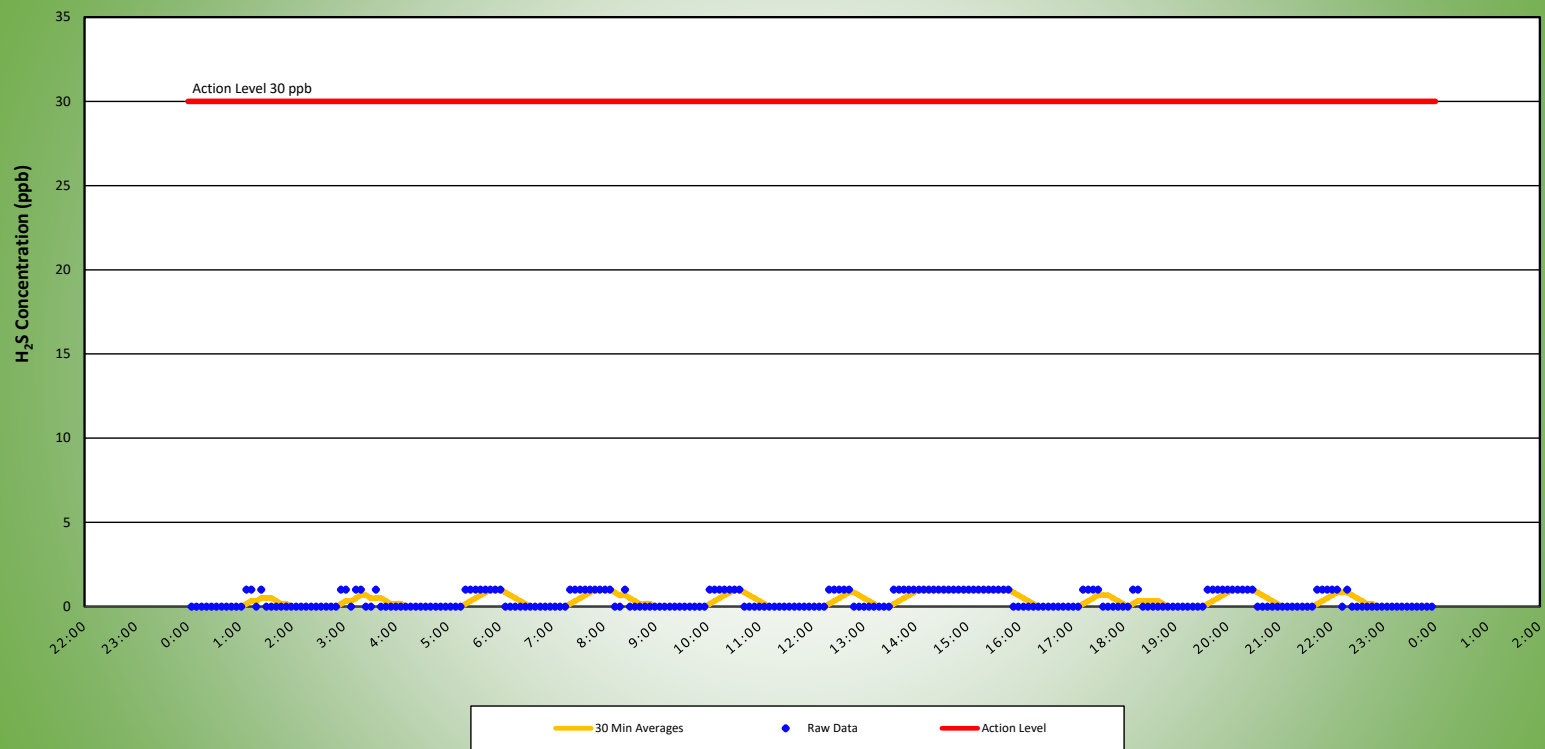

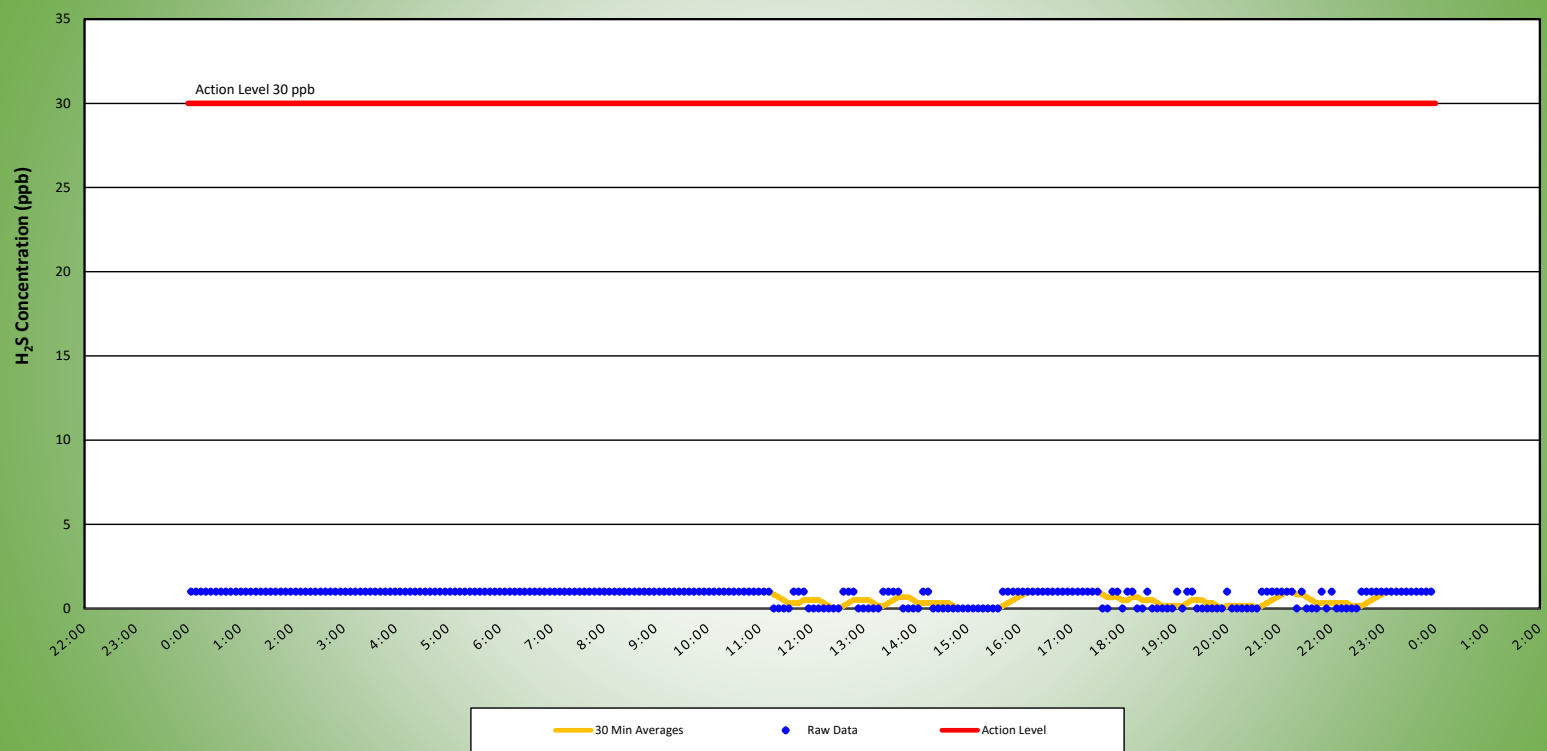
