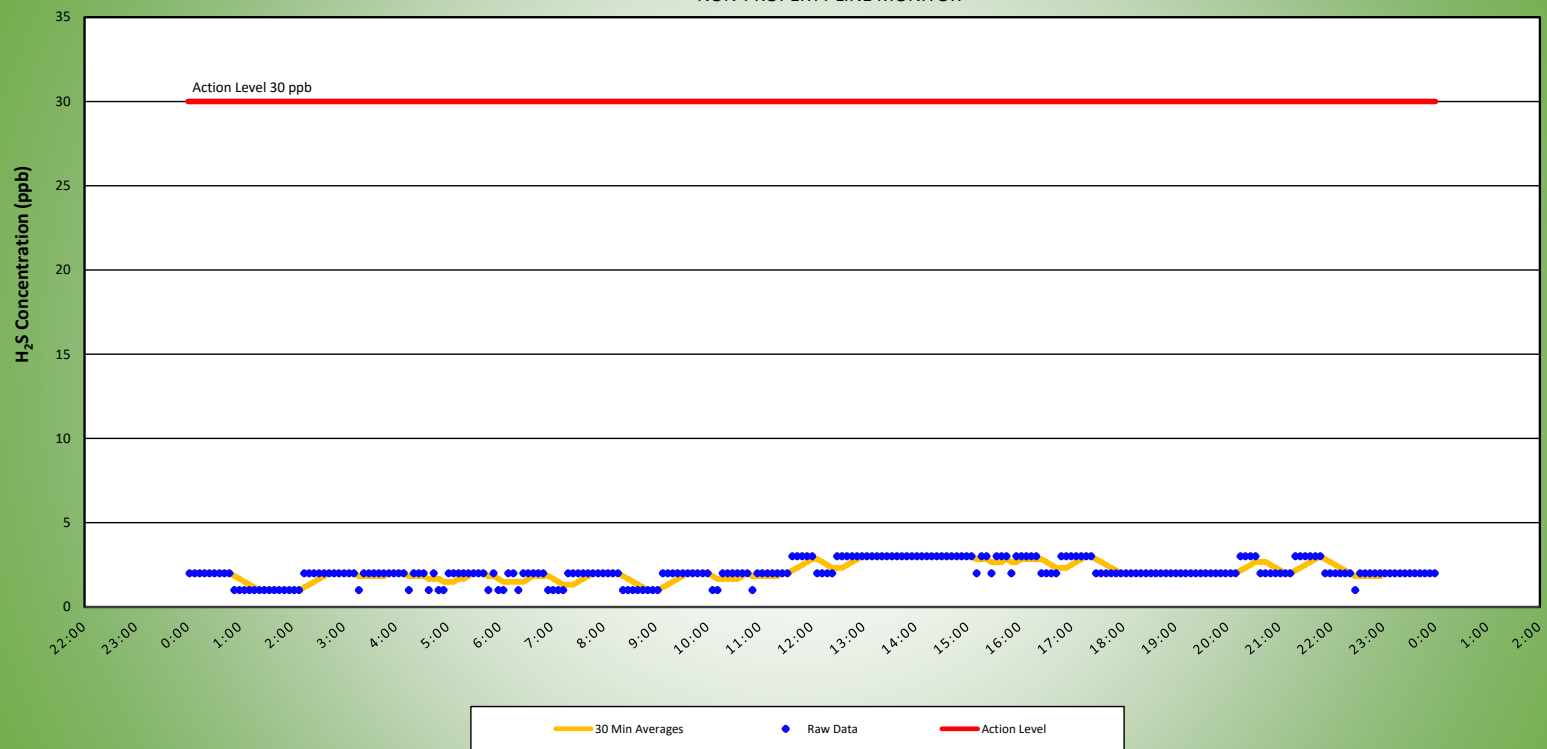
# MS1 H2S MONITORING RESULTS - 06/01/22

NON-PROPERTY LINE MONITOR



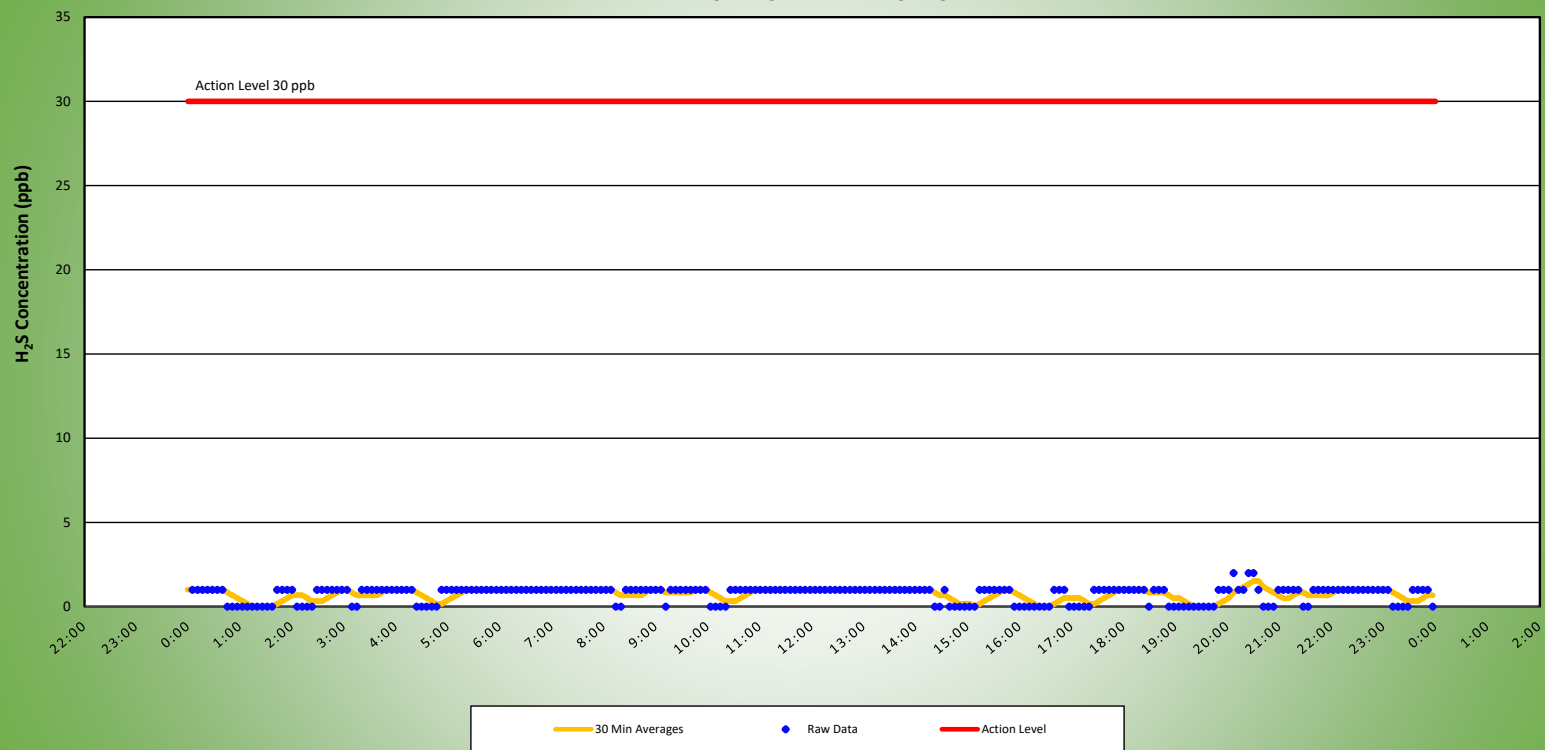
# MS2 H2S MONITORING RESULTS - 06/01/22

NON-PROPERTY LINE MONITOR



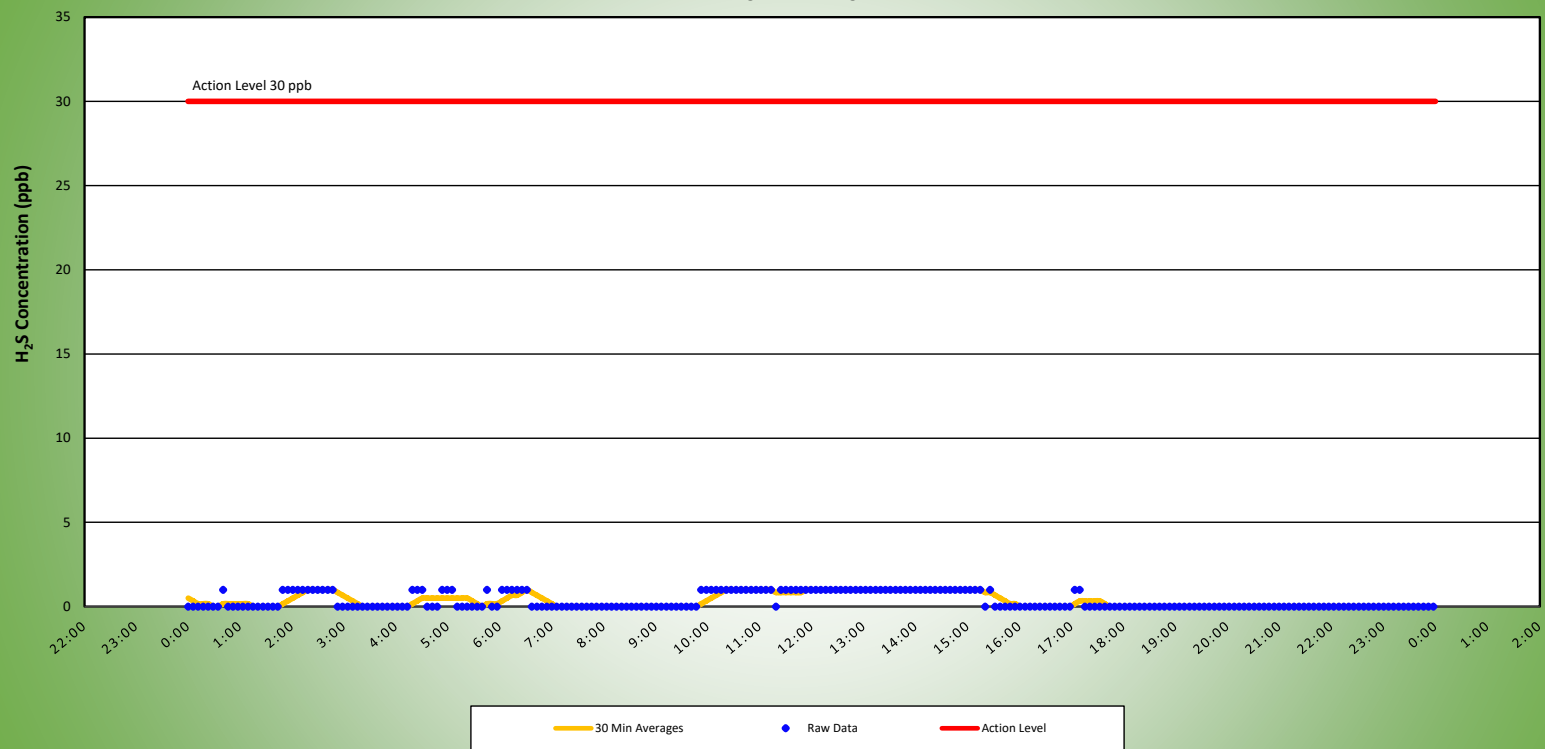

NON-PROPERTY LINE MONITOR



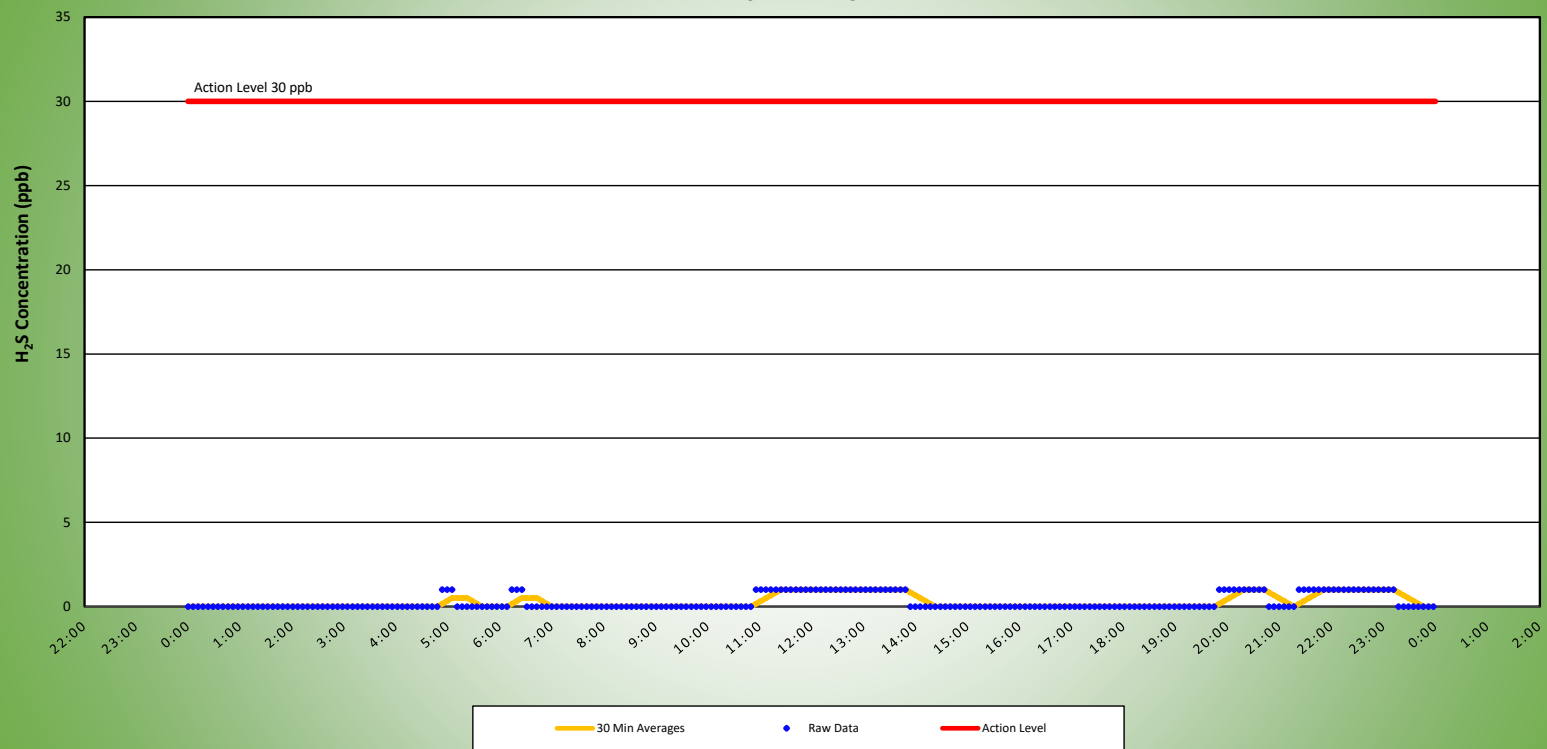

AT OR NEAR PROPERTY LINE



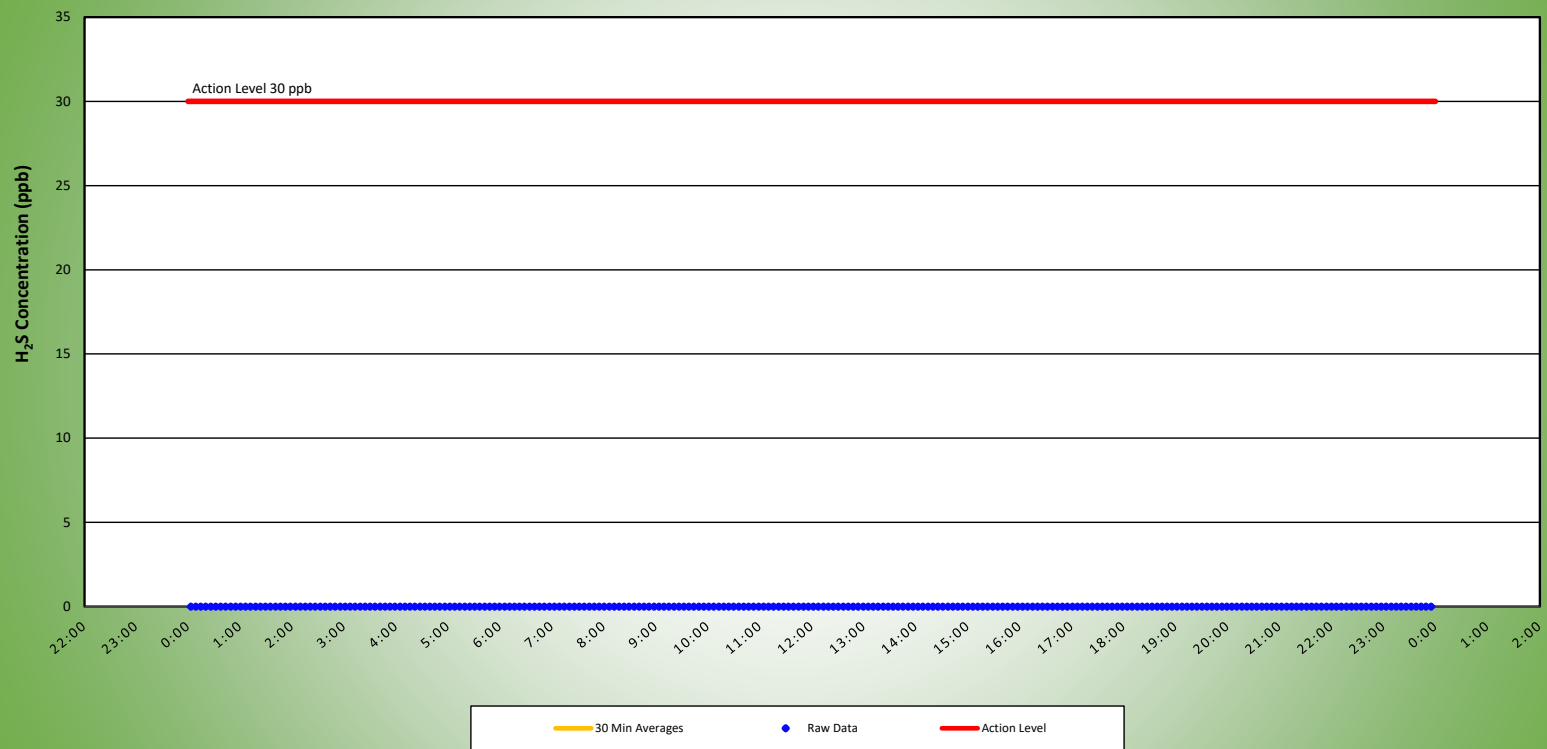

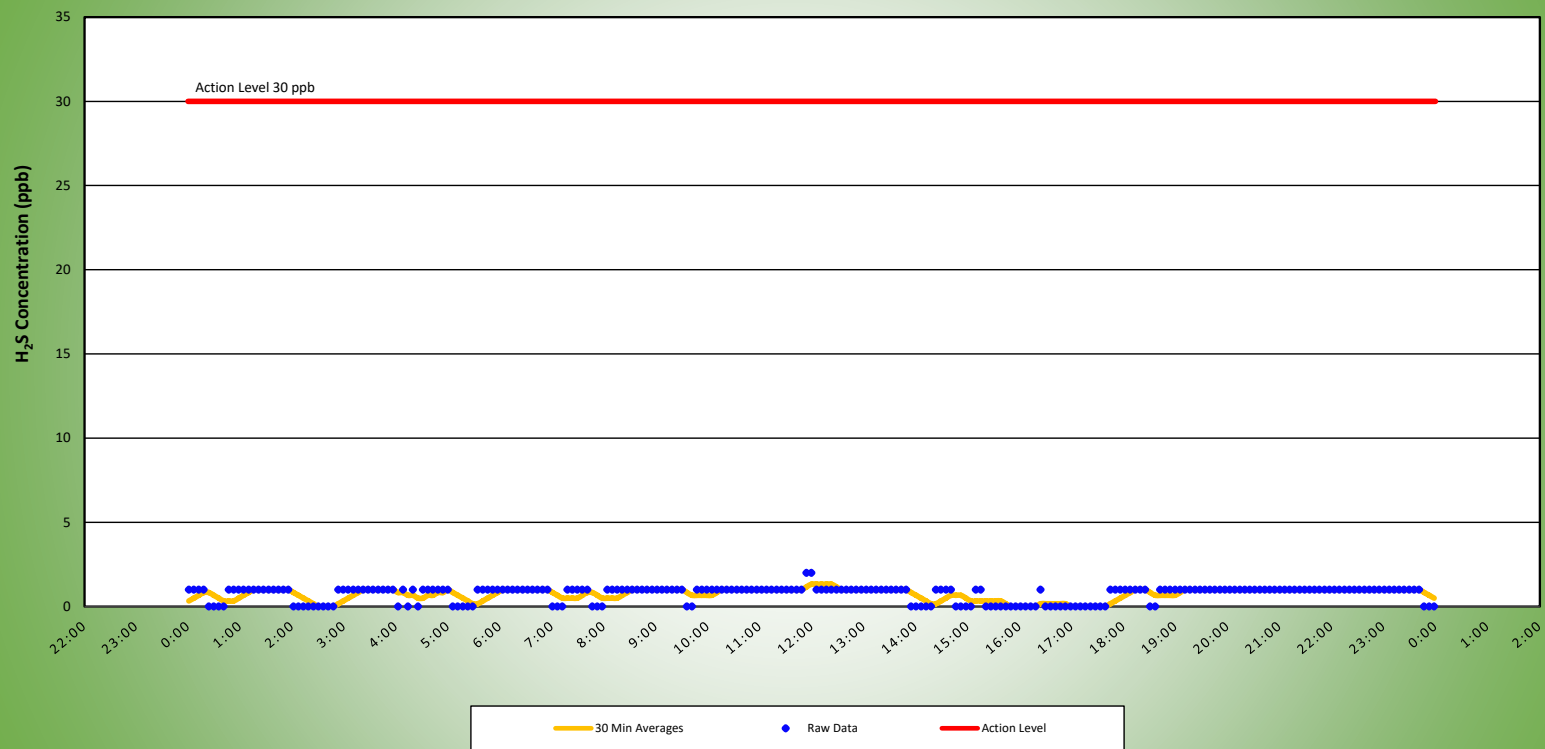
