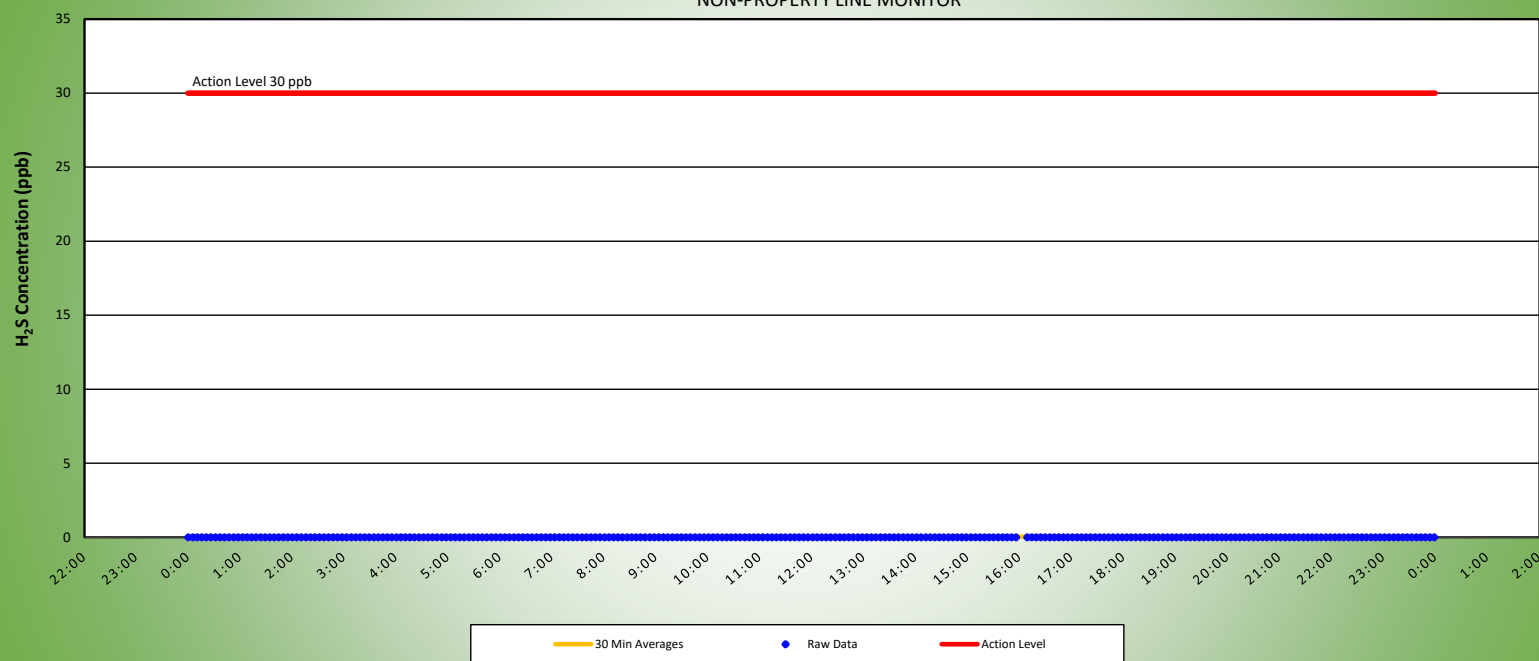
# MS1 H2S MONITORING RESULTS - 03/15/25

NON-PROPERTY LINE MONITOR



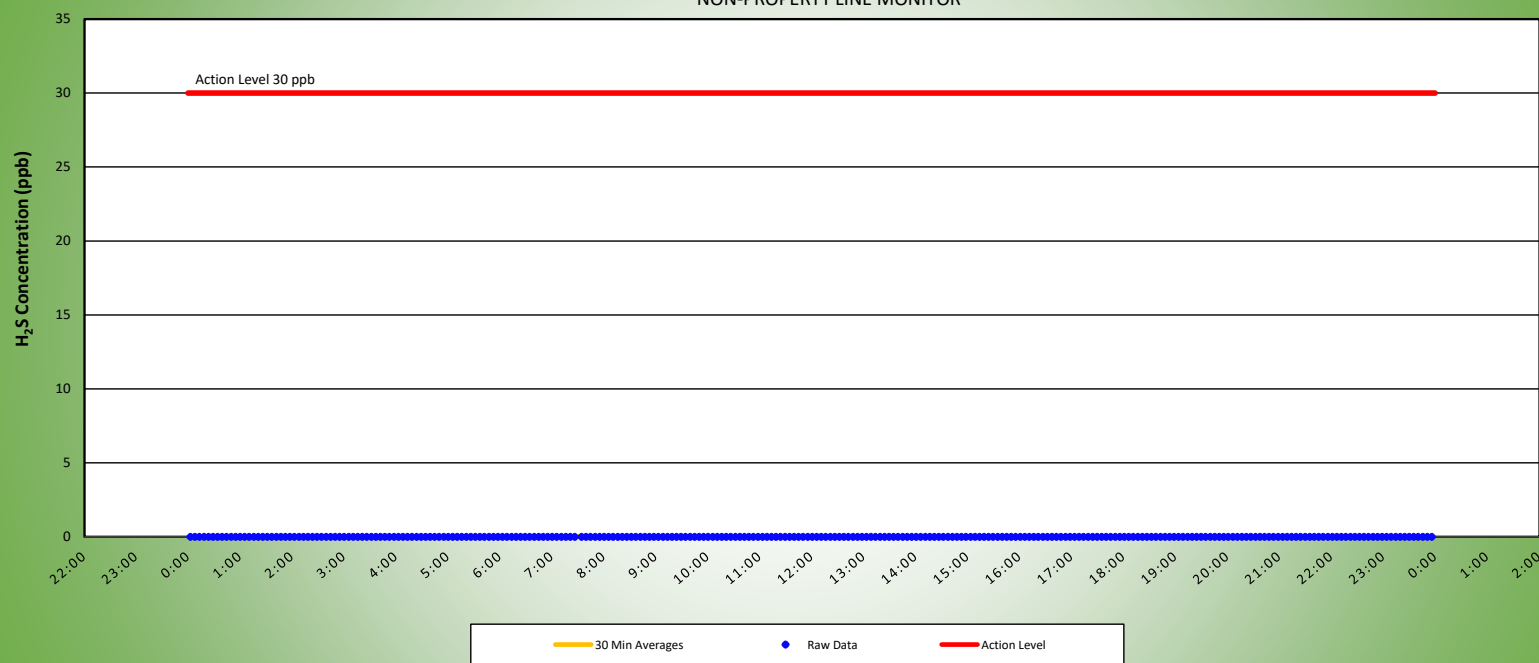
# MS2 H2S MONITORING RESULTS - 03/15/25

NON-PROPERTY LINE MONITOR



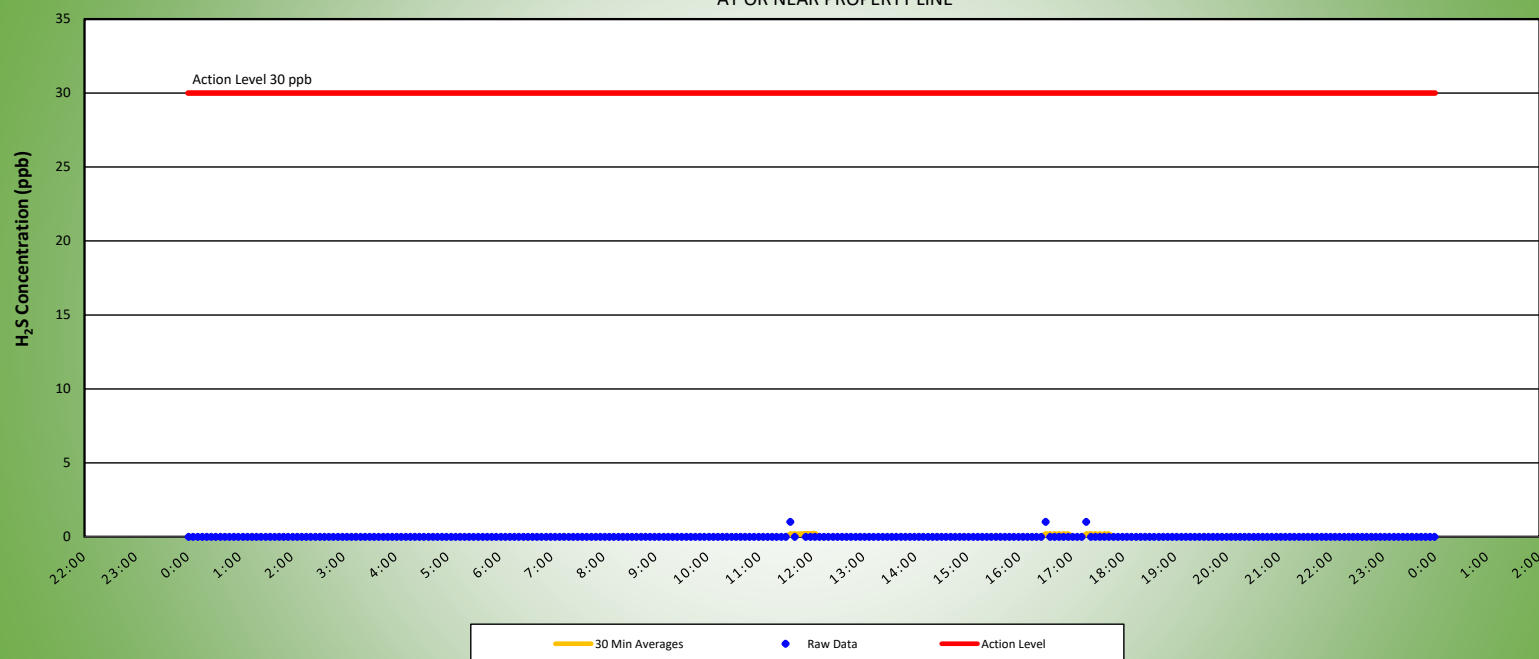

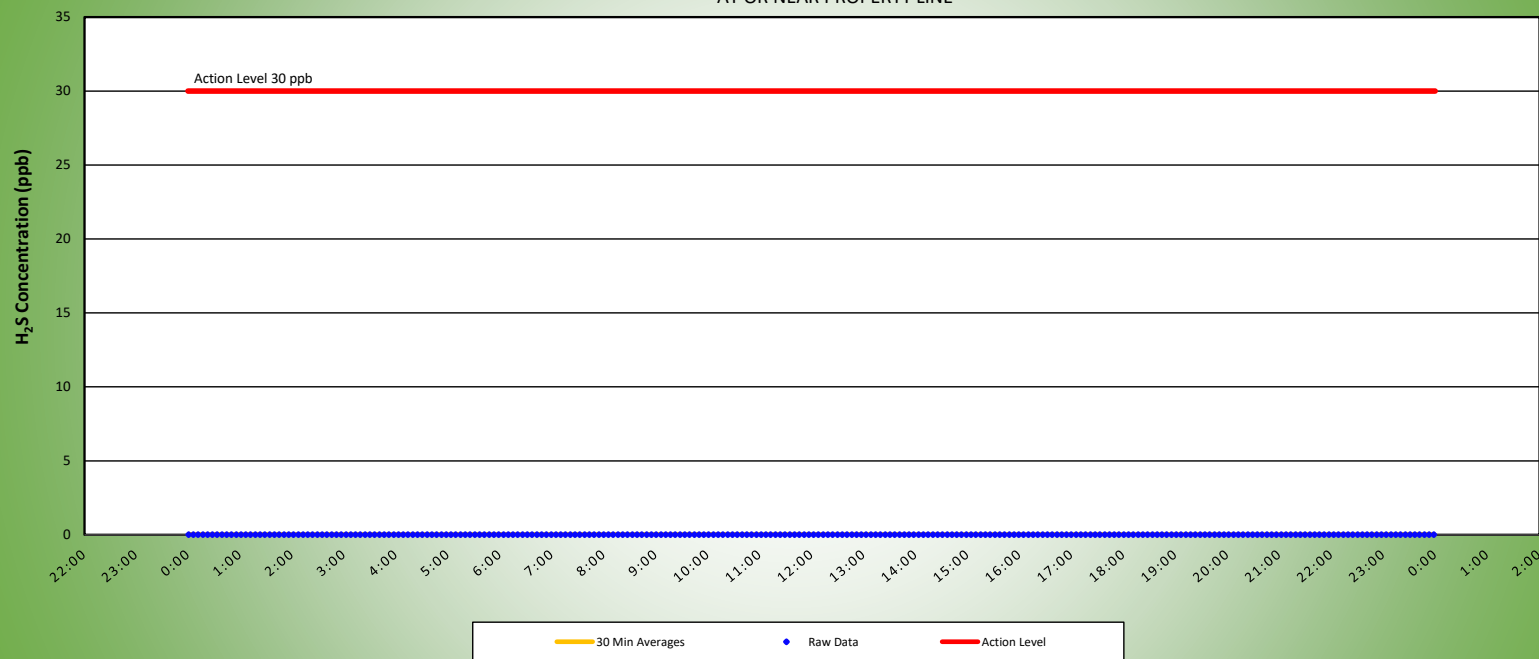

AT OR NEAR PROPERTY LINE



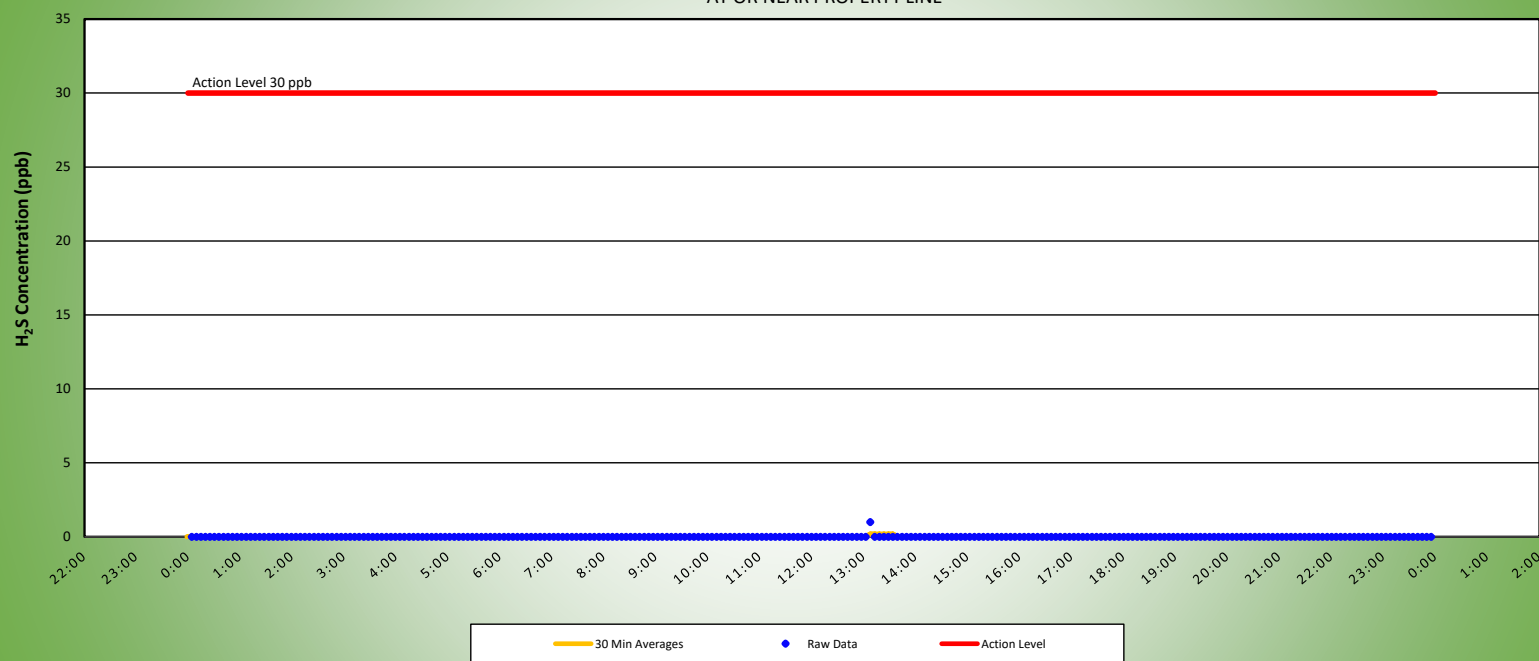

AT OR NEAR PROPERTY LINE



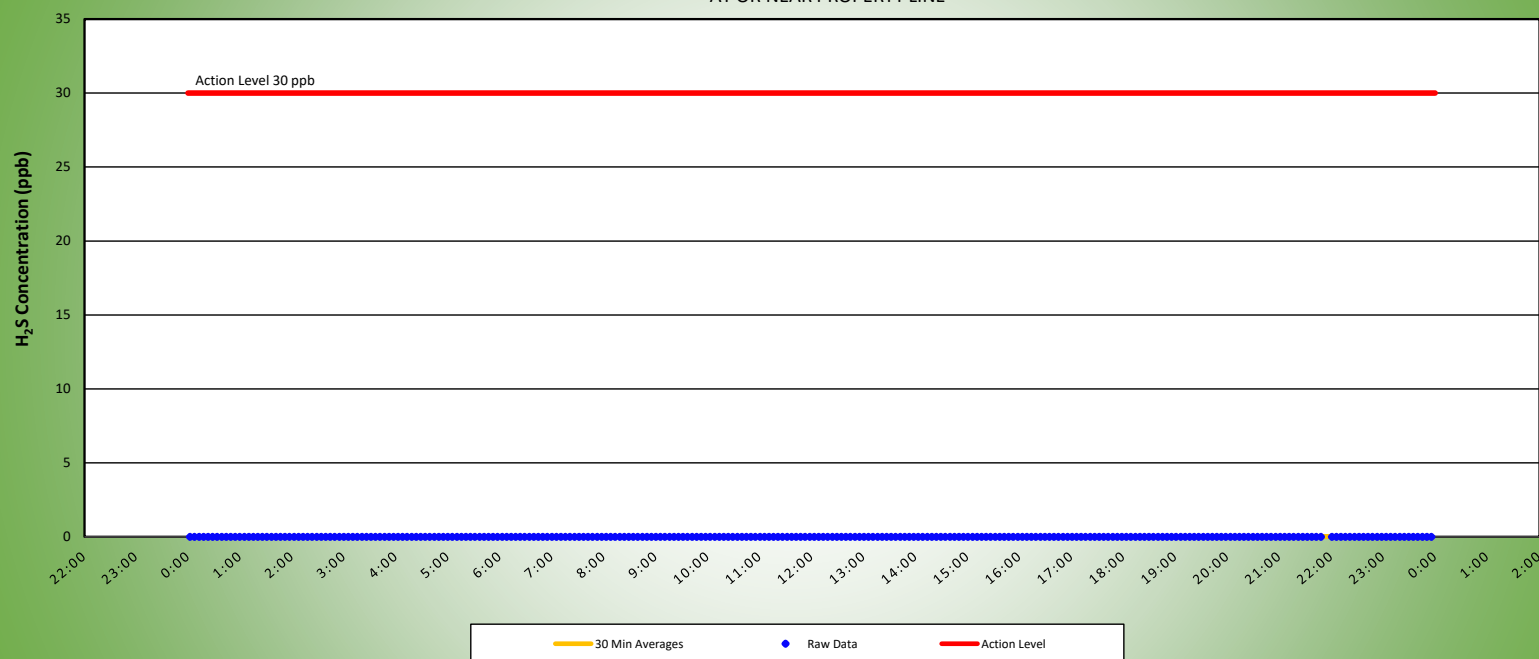
