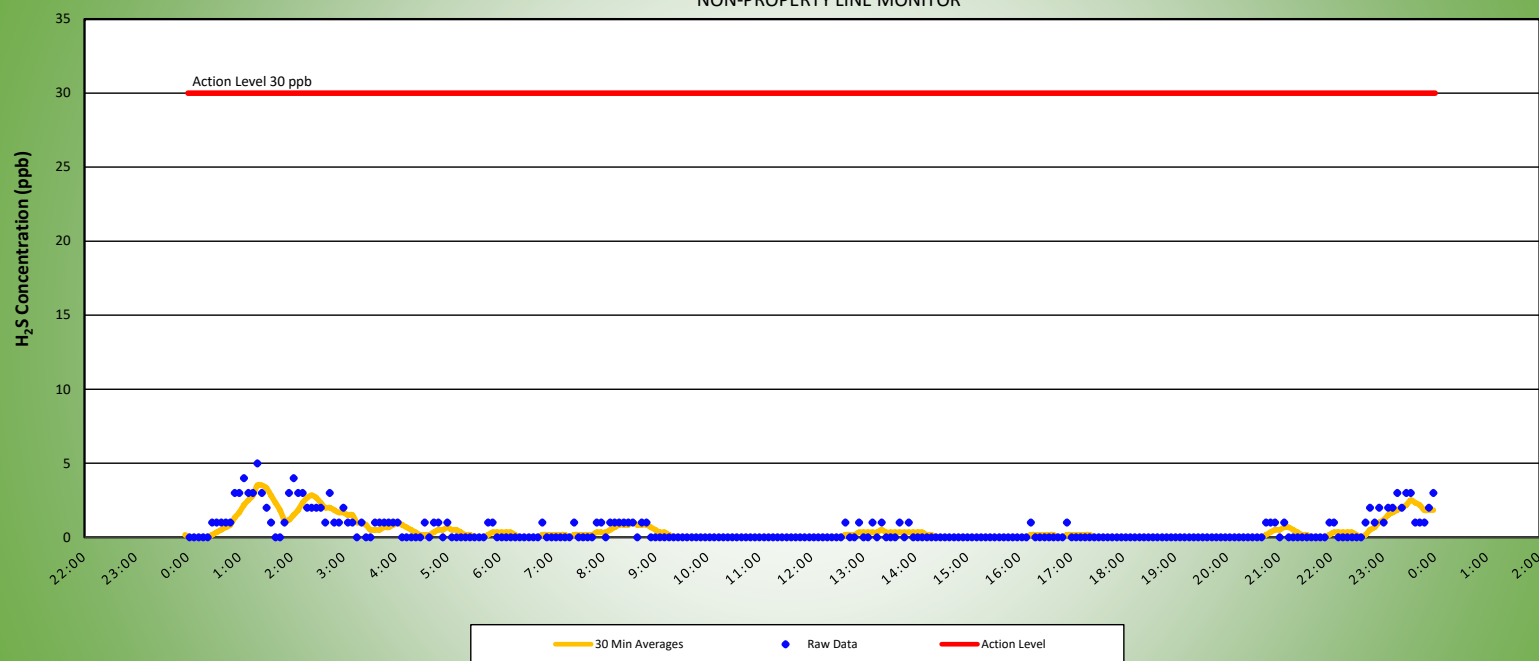

NON-PROPERTY LINE MONITOR



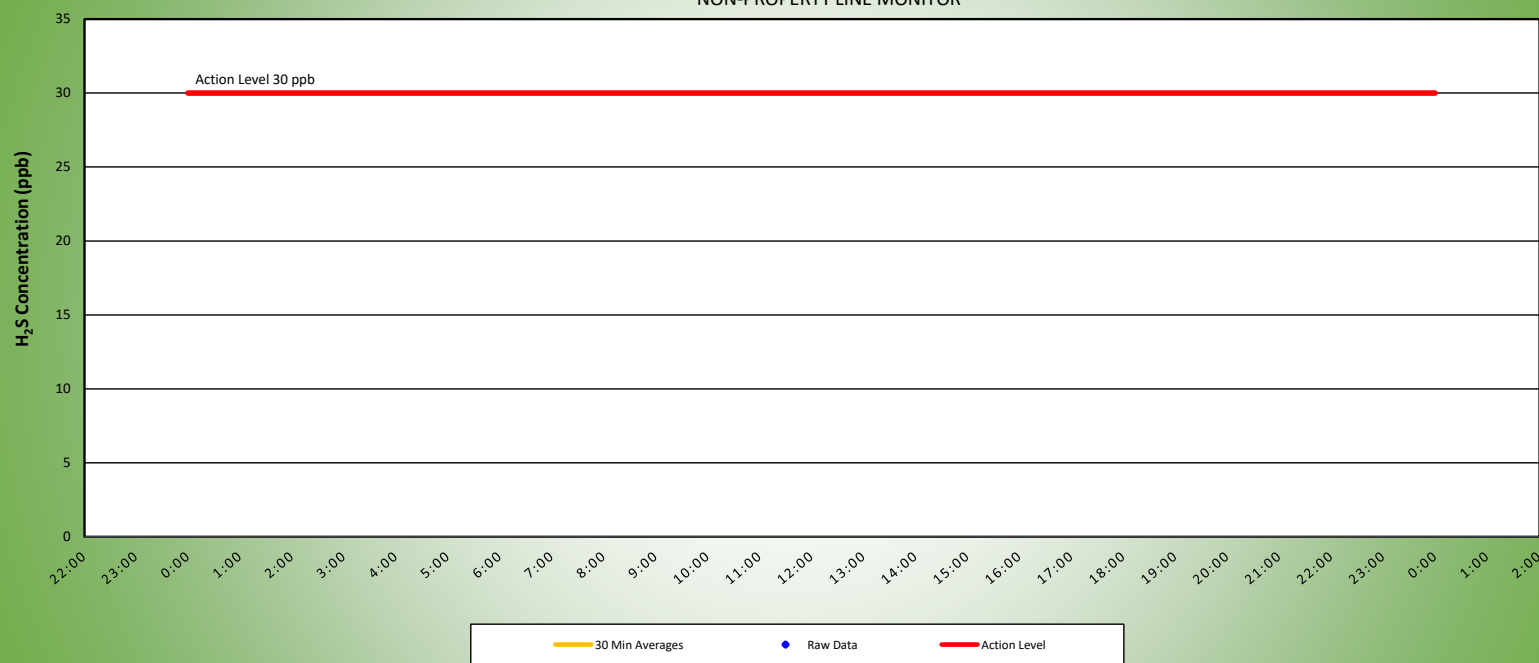

NON-PROPERTY LINE MONITOR



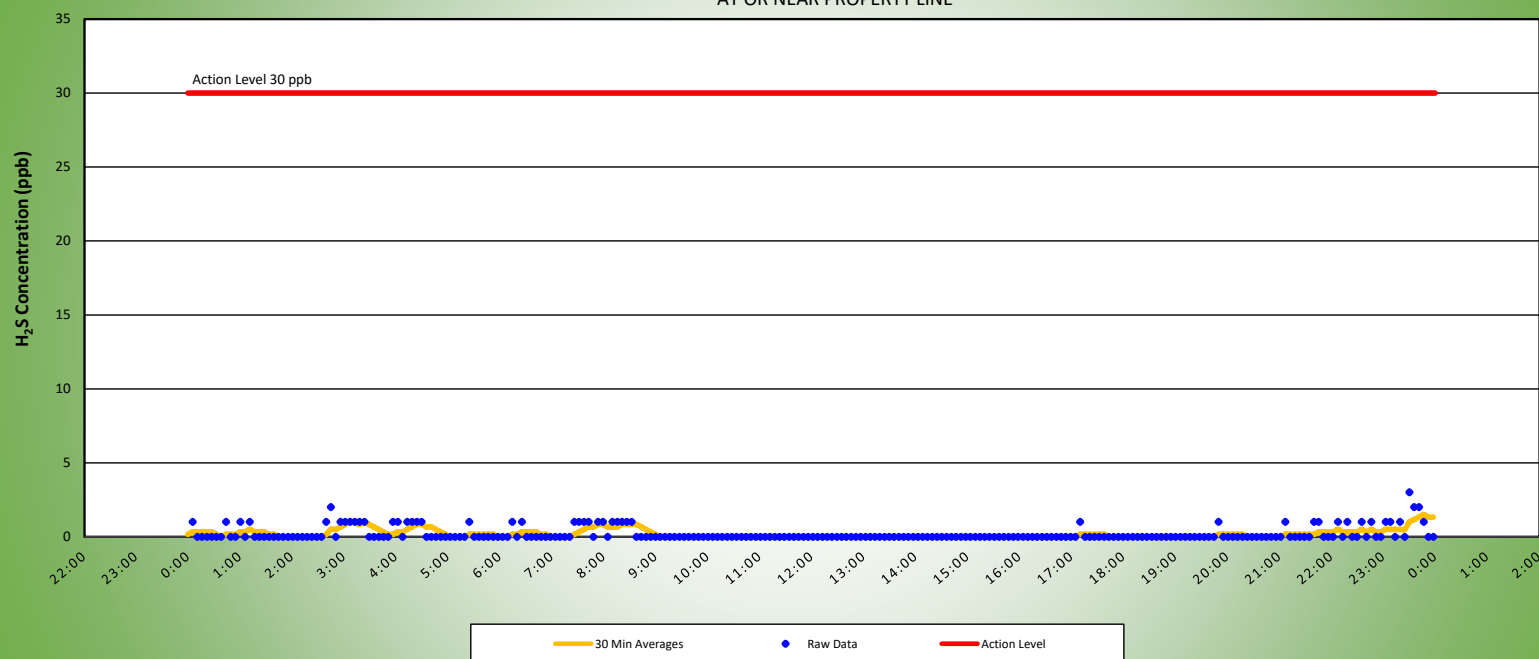

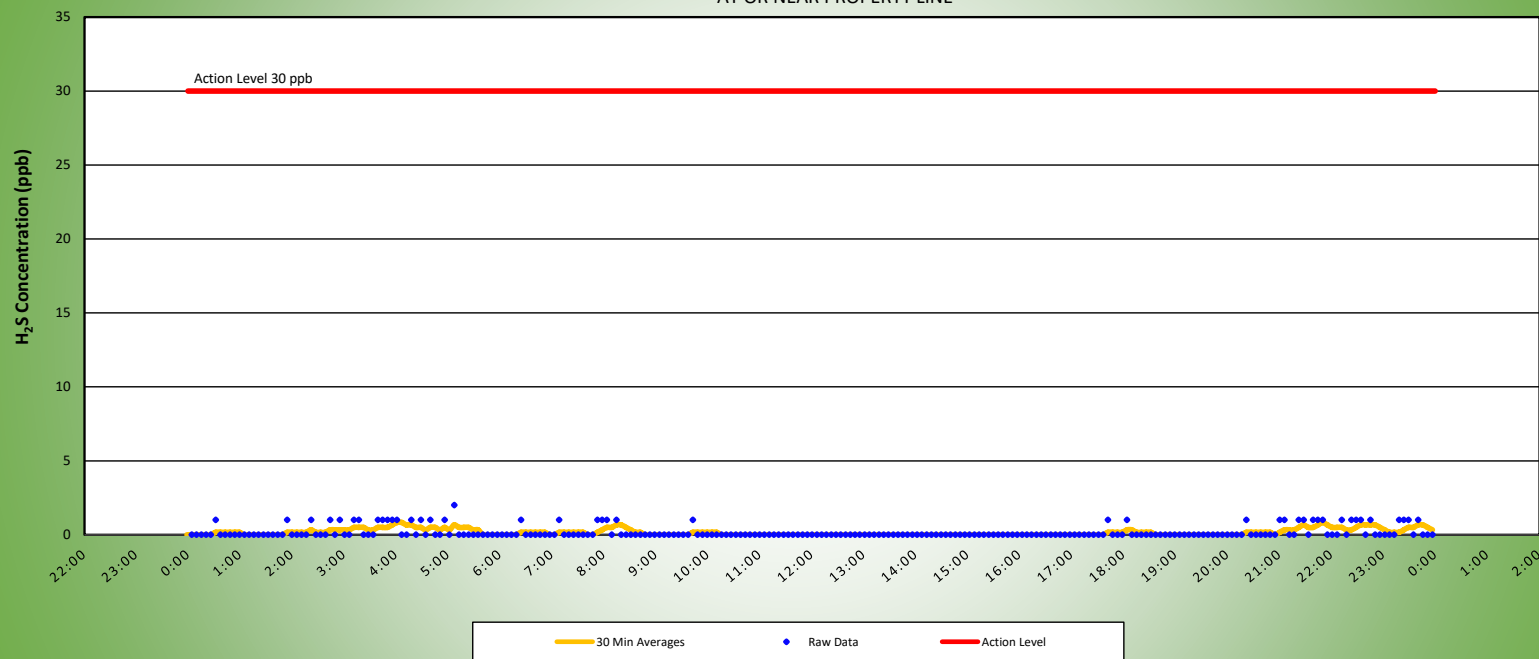

AT OR NEAR PROPERTY LINE



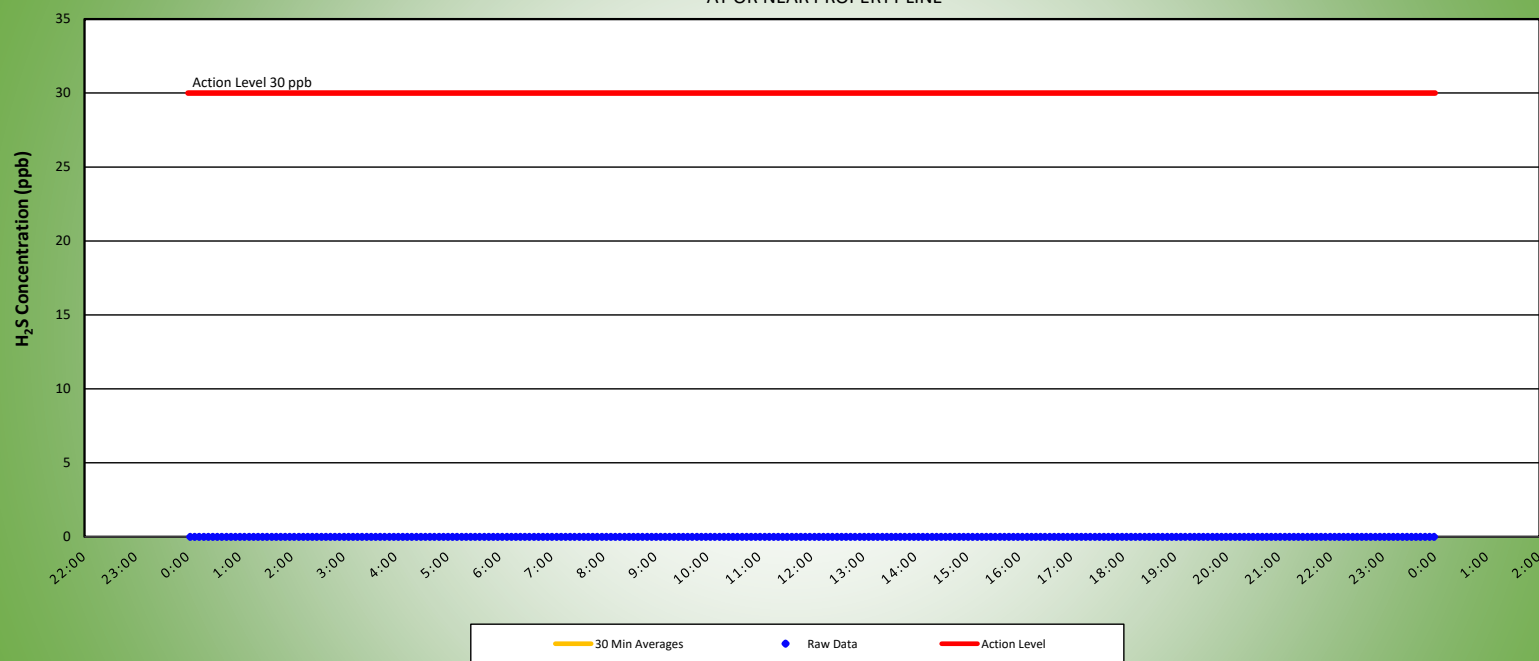

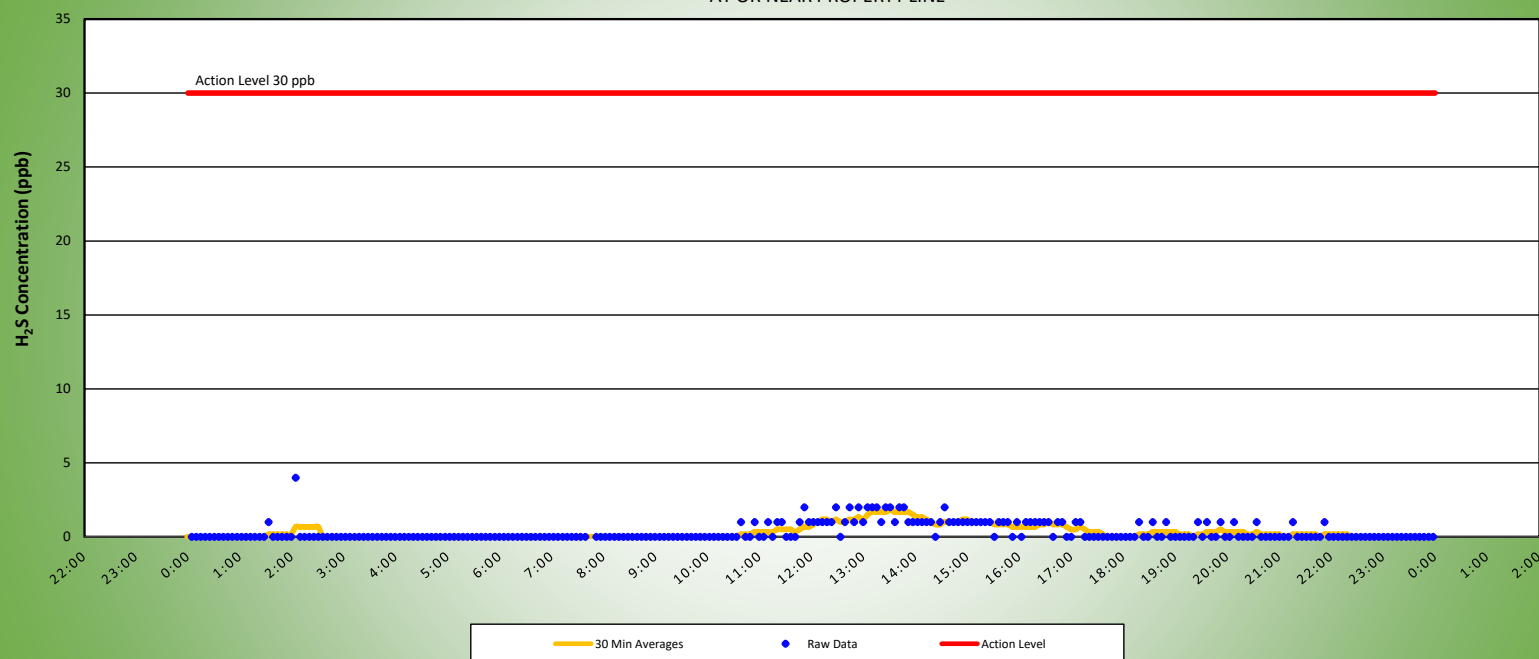
