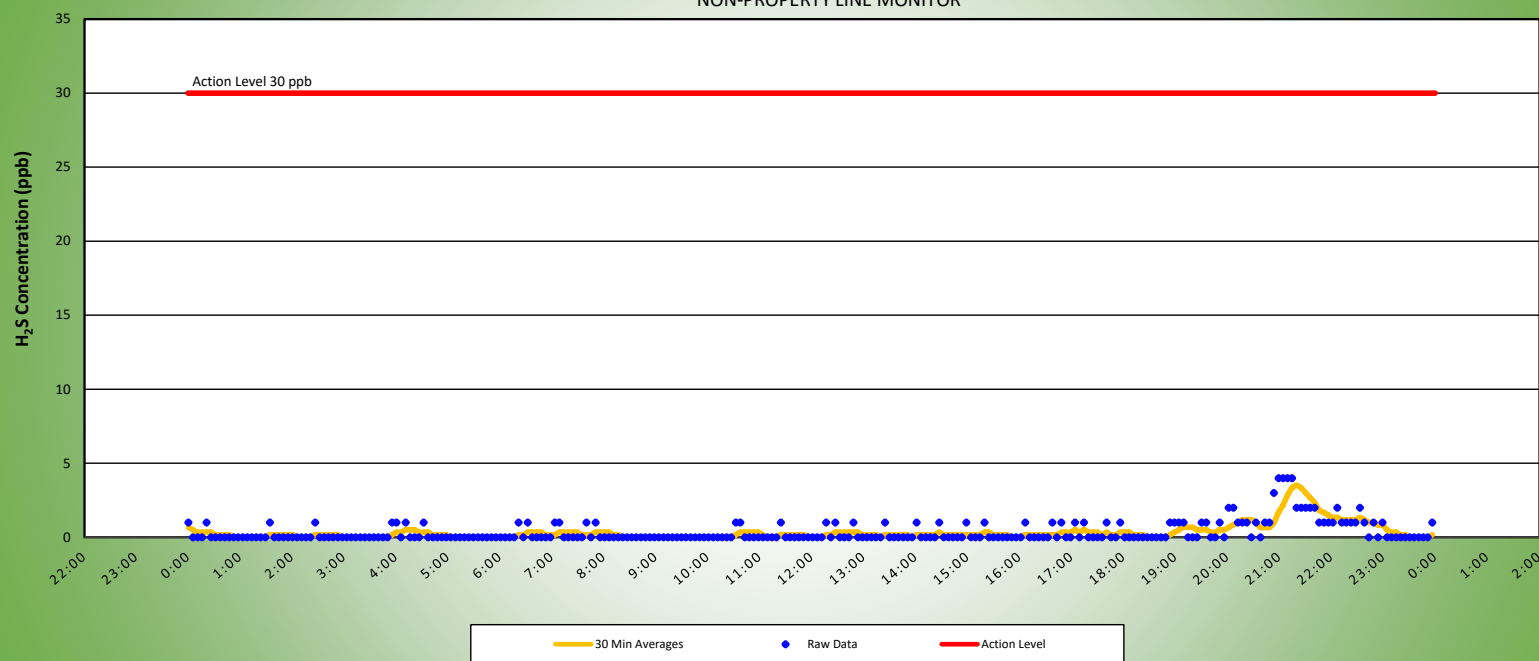

NON-PROPERTY LINE MONITOR



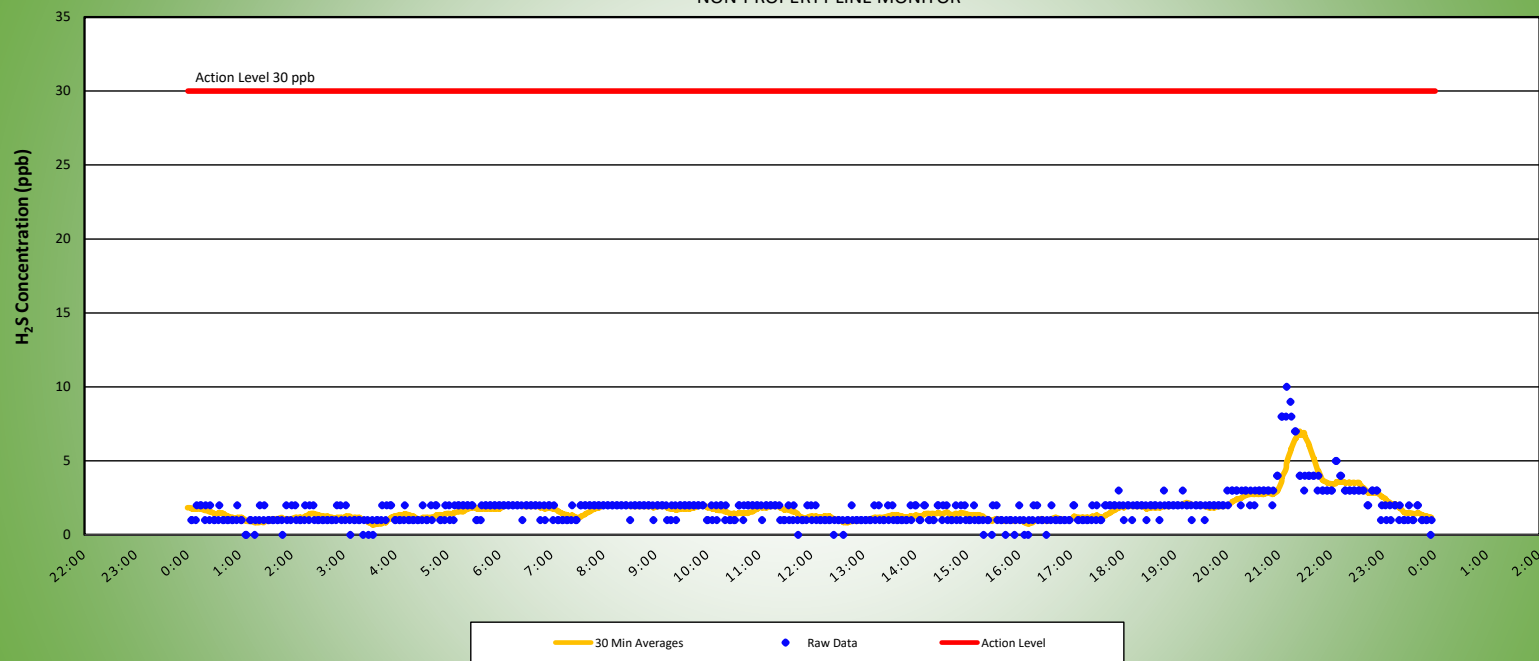
# MS2 H2S MONITORING RESULTS - 04/22/26

NON-PROPERTY LINE MONITOR



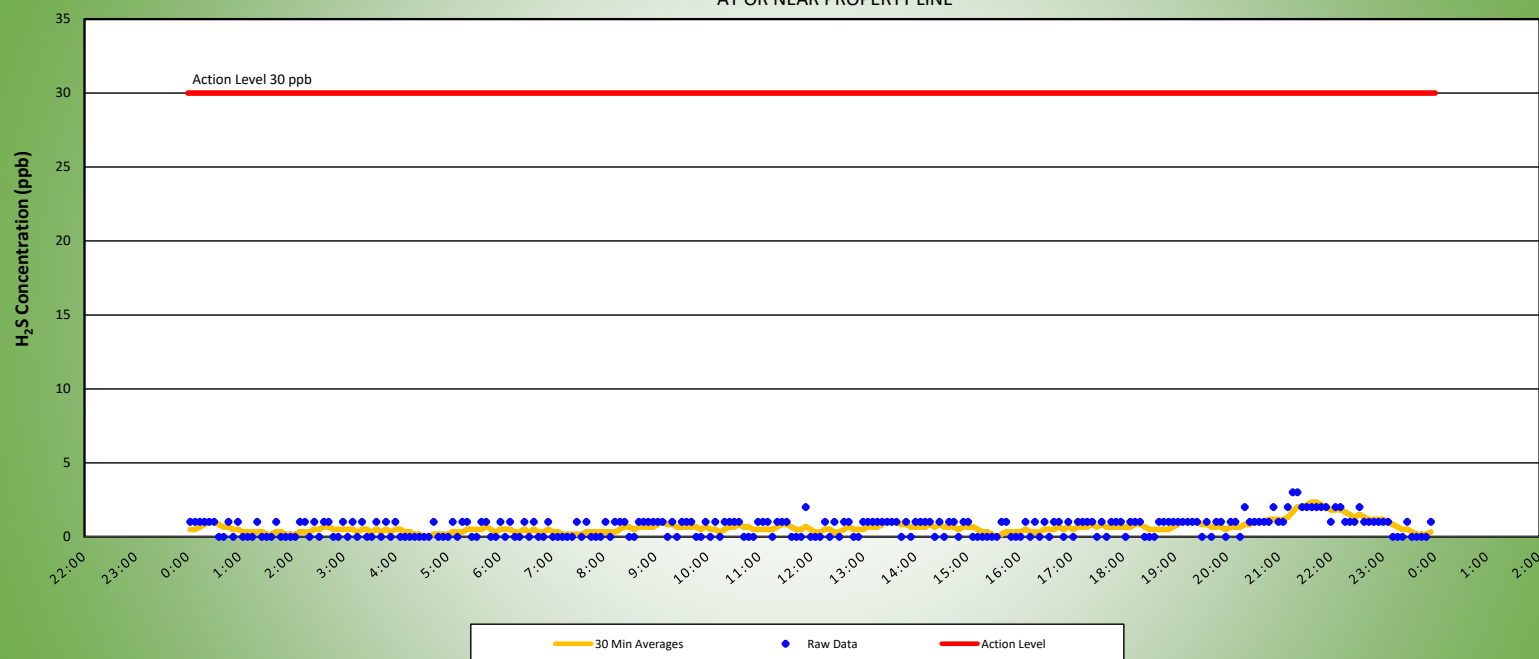

NON-PROPERTY LINE MONITOR



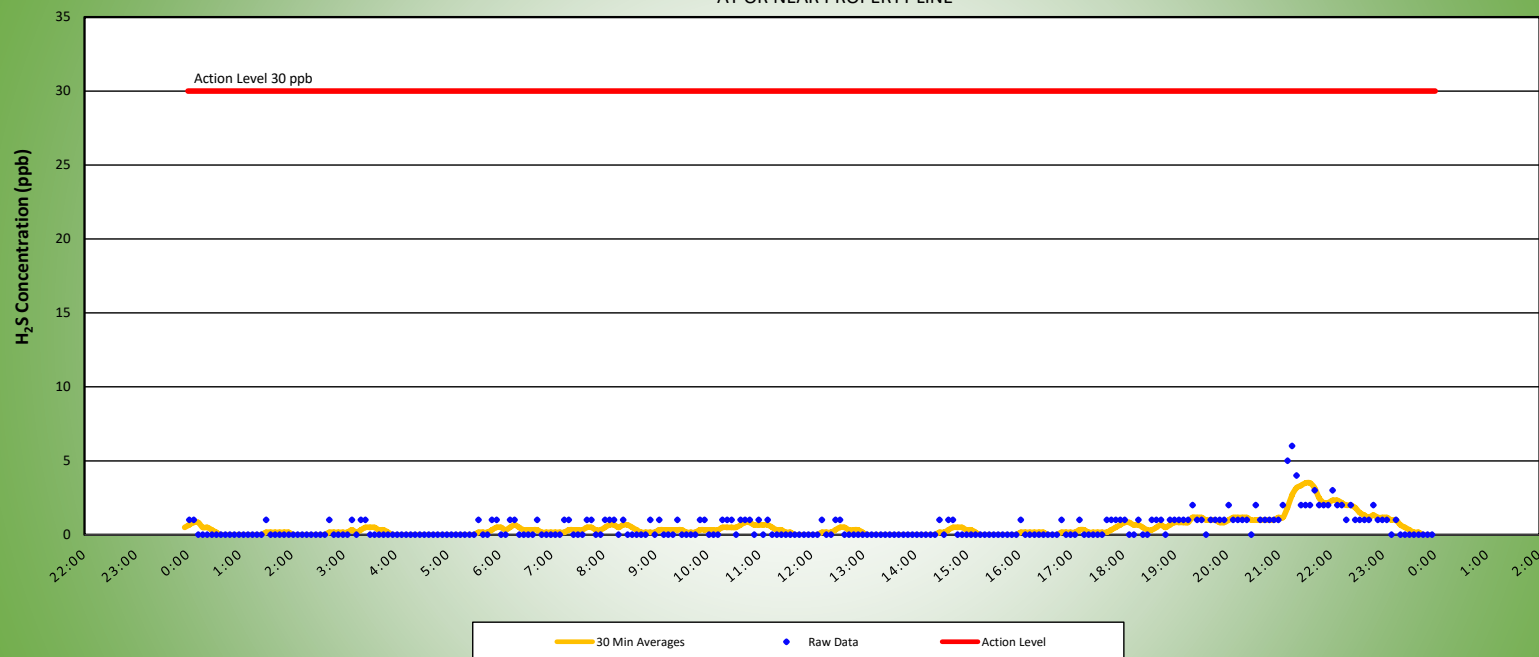

AT OR NEAR PROPERTY LINE



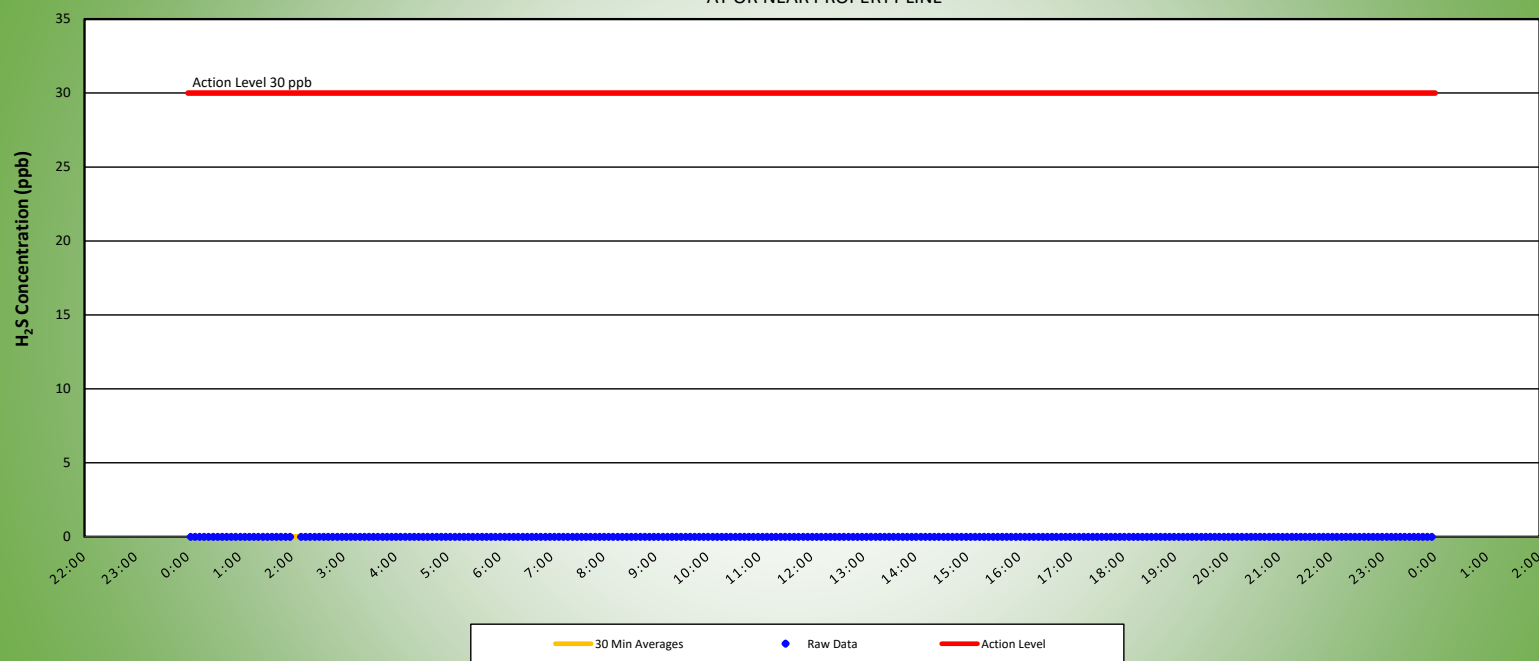

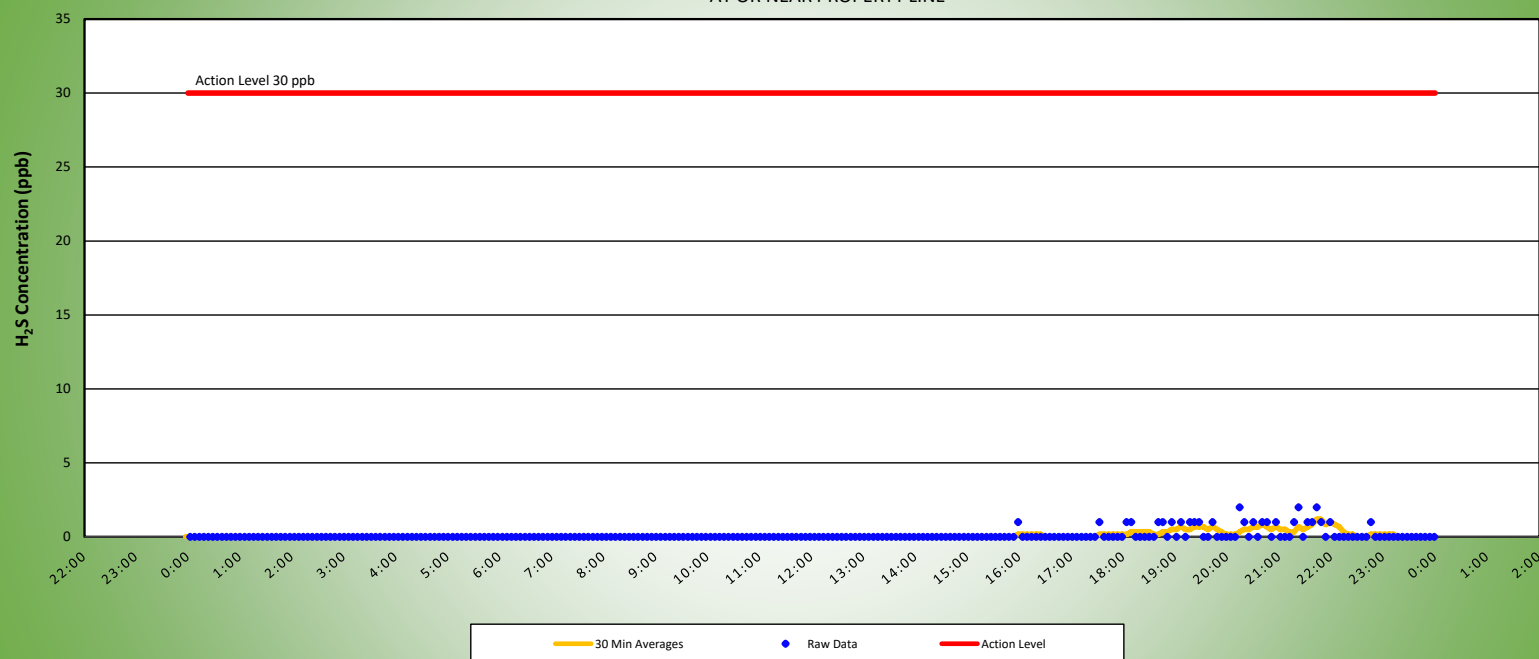
