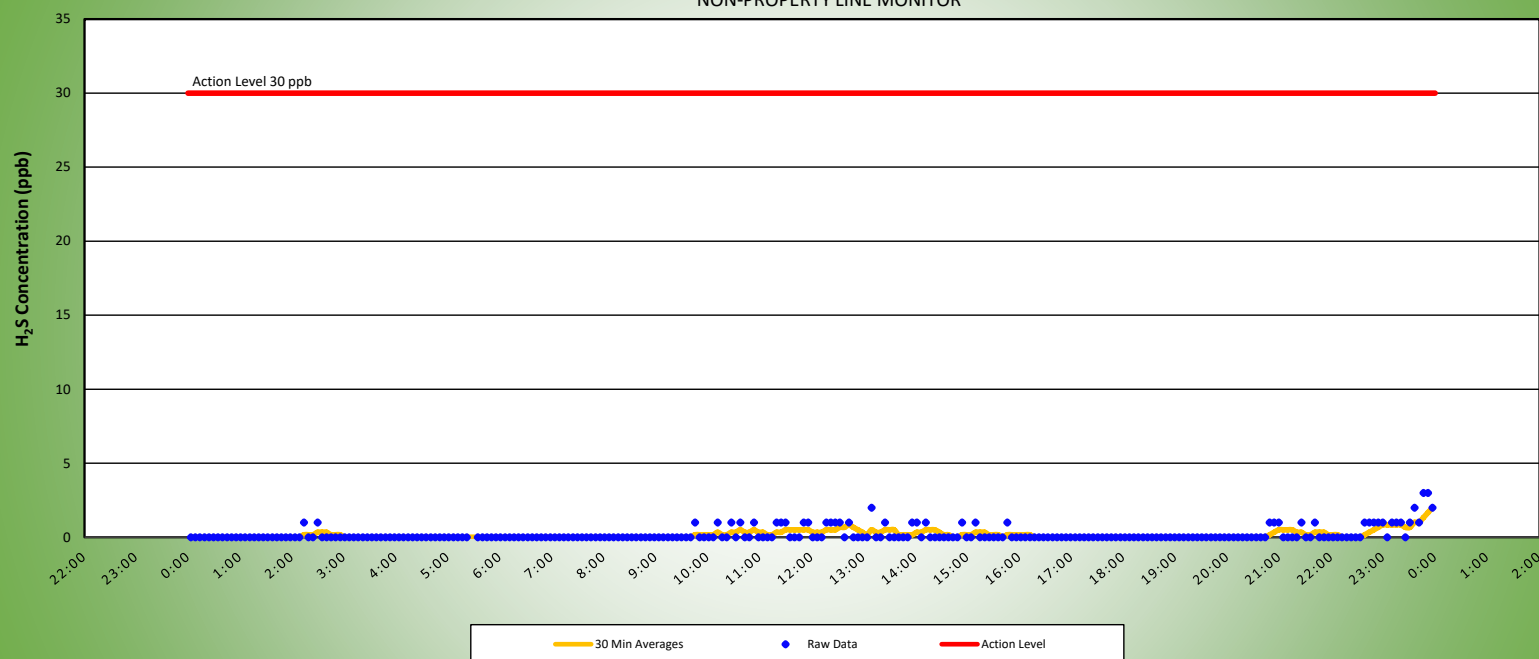

NON-PROPERTY LINE MONITOR



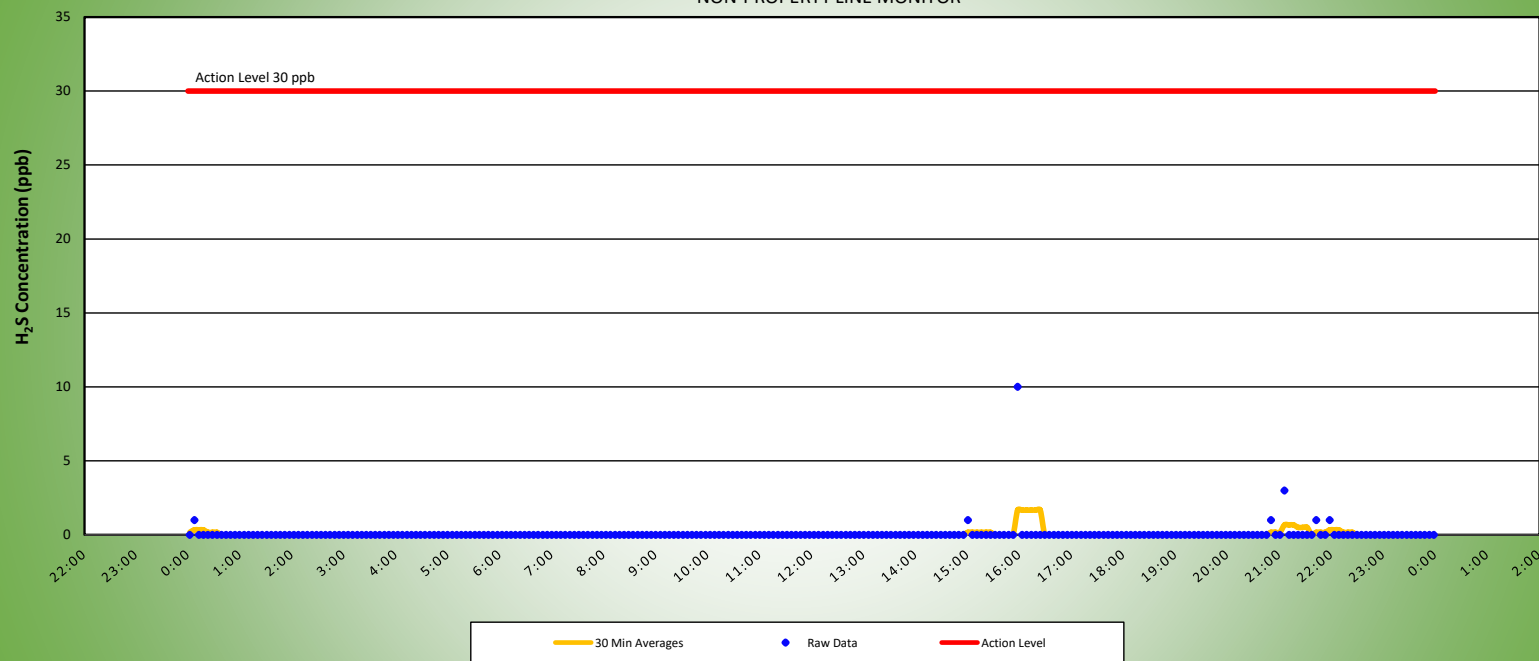
# MS2 H2S MONITORING RESULTS - 08/15/26

NON-PROPERTY LINE MONITOR



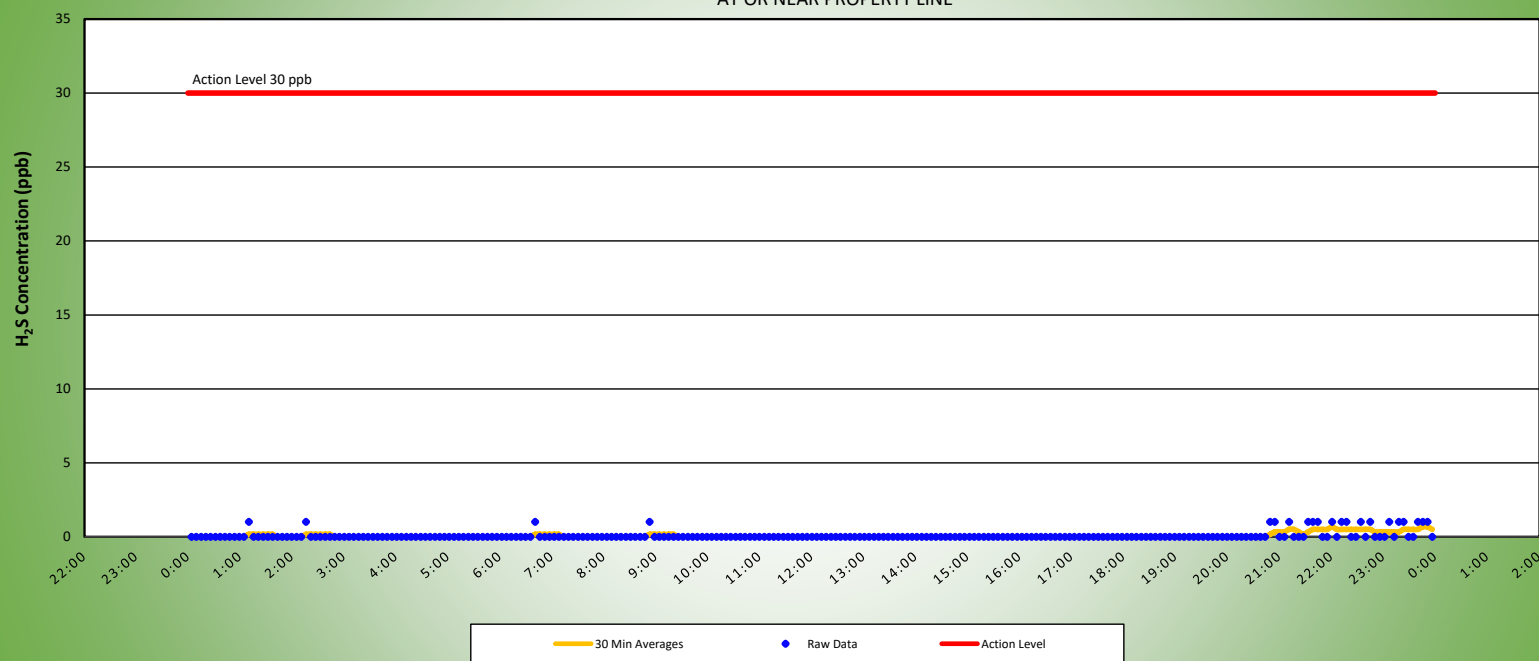

NON-PROPERTY LINE MONITOR



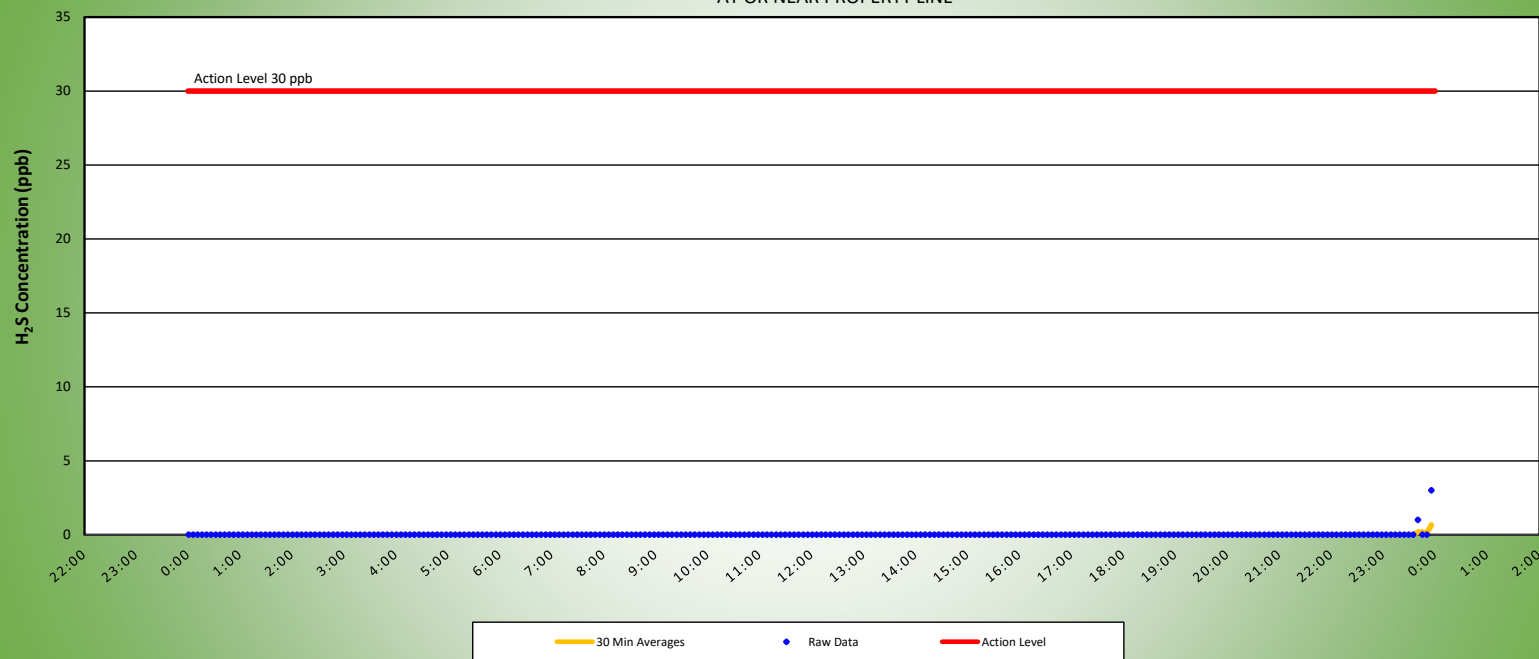

AT OR NEAR PROPERTY LINE



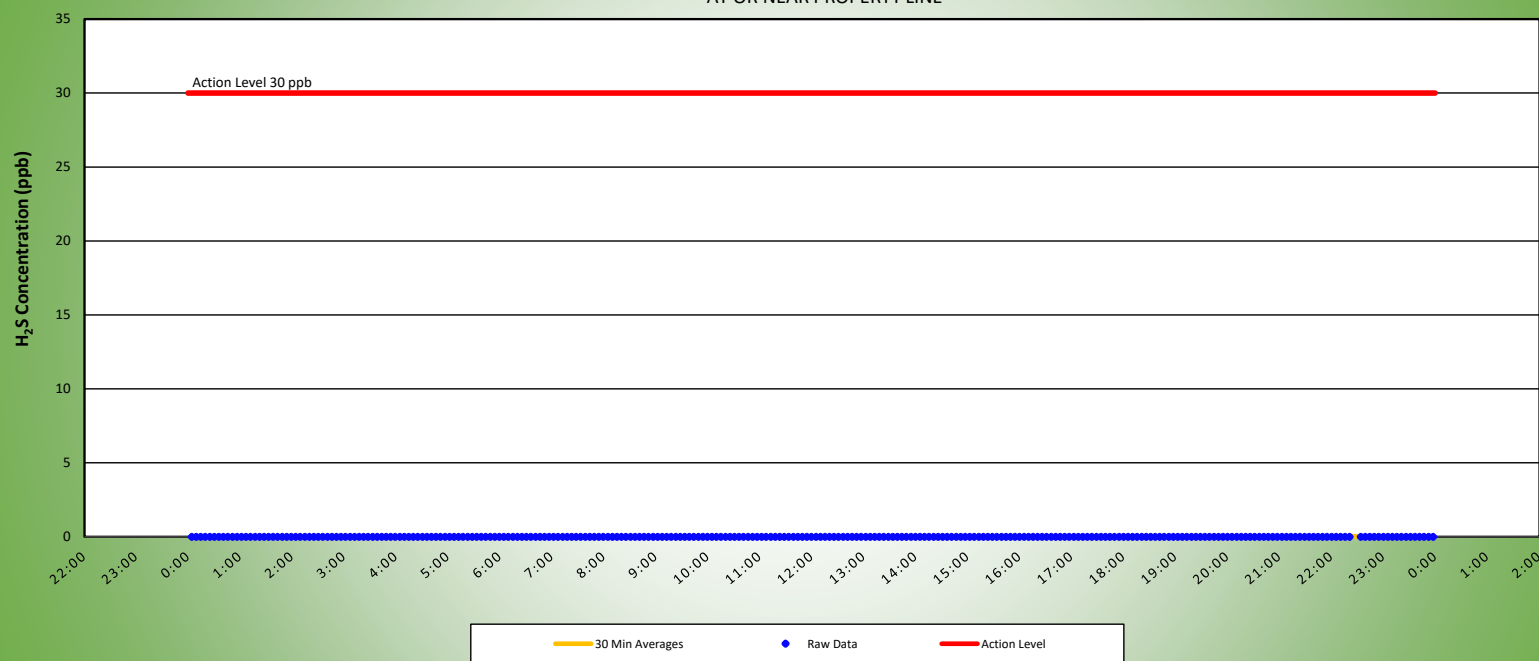

AT OR NEAR PROPERTY LINE



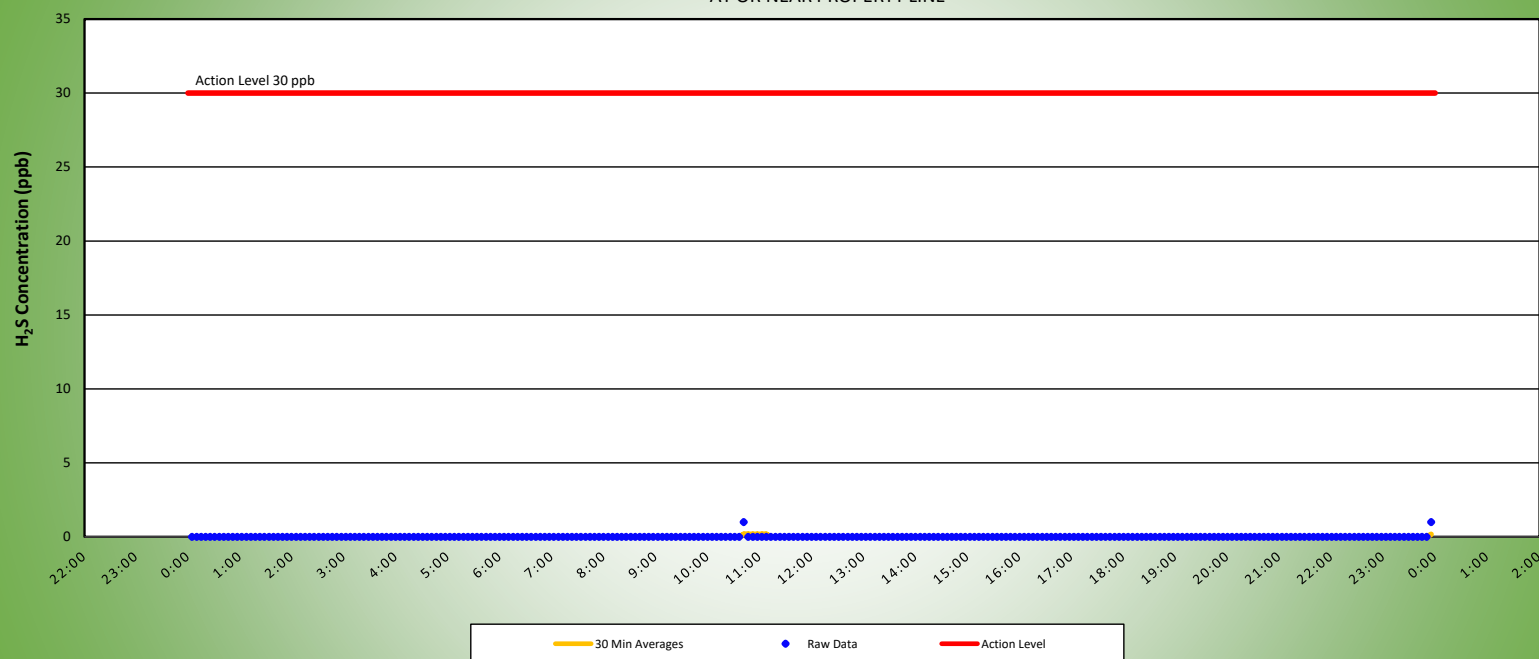
