Chairman Ballantyne called the meeting to order.

#### I. PLEDGE OF ALLEGIANCE

**II.** OPENING STATEMENT – Chairman Ballantyne read the Notice of Meeting required under the Sunshine Law.

#### IV. APPROVAL OF MINUTES AND CASH DISBURSEMENTS

Chairman Ballantyne presented the minutes from the June 22, 2023 Regular Session Board meeting.

Upon motion made by Commissioner Scardino and seconded by Commissioner Plofker the minutes of the Regular Session Board Meeting held on June 22, 2023 were approved with a vote of 15-0, with Commissioner Schaffer abstaining.

Chairman Ballantyne presented the report of cash disbursements over \$100,000 for the month of June, 2023.

Upon motion by Commissioner Fontoura and seconded by Commissioner Stellato the cash disbursements over \$100,000 for the month of June 2023 were unanimously approved.

#### **SPECIAL RECOGNITION**

Chairman Ballantyne announced the retirement of Vincent Prieto as of July 31, 2023. He stated that Mr. Prieto has been President and CEO of the NJSEA for the past 5 years, a tireless public servant for more than 25 years, including time as Speaker of the General Assembly, and a great champion and longtime resident of the Meadowlands. Chairman Ballantyne spoke about Prieto's time as Speaker of the Assembly, during which time Prieto drafted the enabling legislation that merged the NJSEA and the former New Jersey Meadowlands Commission. He explained that President Prieto played a key role at the NJSEA in helping to deliver national and international sporting events to MetLife Stadium, including the FIFA 2026 World Cup. He noted that President Prieto also enacted the merger of the NJSEA Meadowlands Environmental Research Institute and Natural Resources Department. He said that these were just a few examples of his numerous achievements and accomplishments throughout the course of his career. He said that Prieto has made a true difference in improving the lives of those who reside in the Meadowlands, and throughout the State. Chairman Ballantyne when on to say that Prieto was a very close friend and confidant and that he always enjoyed his kind counsel as the Chairman. He pointed out that Prieto had an amazing human interest story that began from the time he came here from Cuba with his mom. He stated that he was a great mentor to many people and that his contributions have made the working men and women's lives better in this State. Chairman Ballantyne read Resolution 2023-29 - Resolution Honoring Vincent Prieto For His Outstanding Public Service To The New Jersey Sports And Exposition Authority And The State of New Jersey into the record.

Chairman Ballantyne presented Resolution 2023-29. Upon unanimous motion by all of the Commissioners, Resolution 2023-29 was approved by a vote of 15-0.

Chairman Ballantyne recognized another retiree, Marylee Vignola. He stated that Vignola devoted her entire life to the NJSEA and the Meadowlands District. He noted that he first met Vignola when he was a young business representative and she welcomed him with a great smile and professionalism. He said that when he later came on board at the NJSEA, she showed the same type of enthusiasm in her work. He thanked her for her dedication and hard work as it really made things run smooth. He mentioned that Vignola had experienced some difficulties in her personal life recently and even with all the stresses she always came to work with a smile on her face. He said she was an absolutely amazing individual. He recognized her husband, Pete and daughter, Nicole who were in attendance. He then presented her with a gift from the Board.

#### VI. APPROVALS

Resolution 2023-30

Consideration of a Resolution Issuing a Decision of the Variance Application Submitted as part of File No. 22-421 Ridgefield Holding/65 Railroad Ave.-Site Improvement (Variance) Block 4014, Lot 10 in the Borough of Ridgefield.

Ms. Sundell stated that Ridgefield Holding Corp. submitted a zoning certificate application for a site improvement at its 18.26 acre property located at 65 Railroad Avenue in Ridgefield, in the Light Industrial B zone. The property, which also contains frontage on Pleasantview Terrace, is currently improved with a 366,631-square-foot multi-tenanted warehouse and distribution facility. She explained that the applicant is proposing to install a paved parking area in the required front yard along Pleasantview Terrace to provide access to tenants located in the southeasterly portion of the multi-tenanted building and had requested one bulk variance from N.J.A.C. 19:4-8.2(b)1, which prohibits vehicular use areas in required front yards. She said that the parking area was proposed at a setback of 25.1 feet along Pleasantview Terrace, whereas a 35-foot minimum front yard setback is required in the Light Industrial B zone. She noted that the subject property was unique as it contained extensive frontage along both Pleasantview Terrace and Railroad Avenue, which limits the location of where parking areas can be constructed outside of a required front yard. She added that the westerly and northerly portions of the property contain the bulk of existing parking for the site. She explained that these areas were located too remotely from the southeasterly portion of the site to effectively serve the tenants in that area of the building, which is currently occupied by 21 tenants, and may accommodate up to 37 individual tenant spaces. She also explained that the tenant spaces to be served by the proposed parking area were not safely accessible from other parking areas on the site due to the presence of active front yard loading areas along both Pleasantview Terrace and Railroad Avenue. She noted that landscaping would be provided to screen the proposed parking area and to prevent headlight glare, and approximately 28 percent of the site would remain open space. She also noted that sufficient stormwater drainage would be provided for the proposed parking area. She noted that no public comments were received at the public hearing. She stated that staff was recommending the approval of the requested bulk variance with two conditions:

- The applicant shall provide a revised site plan depicting additional grading and railing details in the vicinity of the proposed parking area, adjacent building entrances, and the existing adjacent loading area to the west of the proposed parking area.
- The applicant shall obtain approval from the Borough of Ridgefield for any relocation of the existing "No Parking" street sign and/or modification of the extent of the yellow curb line on Pleasantview Terrace, prior to construction.

Chairman Ballantyne presented Resolution 2023-30. Upon motion by Commissioner Scardino and seconded by Commissioner Dowd, Resolution 2023-30 was approved by a vote of 15-0.

Resolution 2023-31

Consideration of a Resolution Issuing a Decision of the Bulk Variance Application submitted as part of File No. 23-041 PSE&G/North Bergen Substation – 2nd Half Upgrades (Variances) Block 442.02, Lot 1 (formerly known as Block 442, Lots 6, 7 & 8) in the Township of North Bergen.

Ms. Sundell stated that PSE&G submitted a request for three bulk variances in connection with their zoning certificate application for proposed upgrades at the North Bergen Substation,

which is located within a utility right-of-way adjacent to West Side Avenue and is deemed to be within the District's Light Industrial A zone and subject to the setbacks within that zone. She explained that the first variance request was from N.J.A.C. 19:4-5.77(a)3i, and involves the construction of concrete structures with a minimum front yard setback of 21.4 feet from West Side Avenue, where 50 feet is required; the second variance request was from N.J.A.C. 19:4-5.77(a)3iii, and involves the construction of concrete structures with a minimum rear yard setback of 23.6 feet, where 75 feet is required and the third variance request was from N.J.A.C. 19:4-8.10(a)1, and involves the installation of a fence with a minimum setback of 0.2 feet within the required front yard on the property. She said that the project was proposing the second phase of an upgrade and expansion of PSE&G's substation and explained that the intent of this initiative was to improve the reliability and resiliency of PSE&G's infrastructure by increasing electrical capacity in the area and raising equipment above FEMA's 100-year flood elevations. She said that the existing utility structures at the substation site already have pre-existing nonconforming front and rear yard setbacks of 18.4 feet and 20.1 feet, respectively, and the expansion project proposes additional equipment with similar setbacks. She noted that the concrete structures that are proposed within the setbacks would occupy only a small portion of the lot's overall length. She explained when applying the required front yard setback of 50 feet and the required rear yard setback of 75 feet, the resulting building envelope is only 25 feet wide. She stated that the proposed A-frame equipment foundations cannot be constructed within the remaining 25-foot-wide building envelope. She also explained that the proposed front and rear yard setbacks are necessary to accommodate the needed upgrades to the existing substation on the site, while maintaining adequate area to accommodate required clearances between equipment and structures per the National Electric Safety Code (NESC). She said that all improvements are proposed to be installed over existing disturbed surfaces, including paved and gravel areas, and all structures will be elevated to comply with FEMA requirements and to promote resiliency of the regional electric utility network. She stated that the applicant also proposes to replace an existing non-conforming chain-link-fence with a proposed new section of fencing which will extend approximately 75 feet further toward the south to completely enclose the expanded utility compound and that the proposed new section of fence would have a minimum setback of 0.2 feet from West Side Avenue. She highlighted the fact the if the regulations were strictly applied, the applicant would be unable to provide for a continuous security fence around the site perimeter and, therefore, would be unable to secure the site in accordance with industry requirements. She explained that security requirements for critical infrastructure such as electric substations are heightened in comparison to other permitted uses in the Light Industrial A zone. She said that the requested variances would not impact the provision of light or air to adjoining properties, and would not result in any detriment to area traffic. She said that the existing and proposed substation is unmanned and, therefore, traffic is minimal and would not differ significantly from existing operations at the site. She stated that staff recommended the approval of the requested bulk variances for the reasons stated in the recommendation report.

Chairman Ballantyne presented Resolution 2023-31. Upon motion by Commissioner Dowd and seconded by Commissioner Fontoura, Resolution 2023-31 was unanimously approved by a vote of 15-0.

Resolution 2023-32

Consideration of a Resolution Issuing a Decision on the Suitability Recommendation as Required by the NJSEA Interim Policies Governing Affordable Housing Development in the Meadowlands District File No. 23-206, Forsgate Ventures XIV/10 Polito Avenue – New Building (Variances) Block 227, Lot 1 in the Township of Lyndhurst.

Ms. Sundell advised that a zoning certificate application was received for the construction of a 72,268-square-foot warehouse building at 10 Polito Avenue in Lyndhurst. She noted that the property is a corner lot with frontage along Polito Avenue, the NJ Route 3 and Route 17 interchange, and Garland Way and is currently developed with a vacant hotel and restaurant, which are proposed to be demolished. She stated that the streets are main thoroughfares providing access to the warehouse/distribution, commercial and industrial area in the Lyndhurst Commerce Center. She noted that there are no adjacent residential or other supportive uses that could, from a planning perspective, create a cohesive neighborhood and that the site was remote from public schools, park and recreational facilities, other public amenities and residential neighborhoods. She explained that at 4.64 acres, there is not sufficient space on site to construct a critical mass of housing in a manner that would provide a reasonable separation distance and appropriate buffering between the housing and the adjacent warehouse and truck thoroughfares. She said that staff evaluated the site and prepared a suitability review indicating that the subject property at 10 Polito Avenue in Lyndhurst is recommended to be deemed unsuitable for housing and request that the Board concur with the Review Team's recommendation.

Chairman Ballantyne presented Resolution 2023-32. Upon motion by Commissioner Stellato and seconded by Commissioner Plofker, Resolution 2023-32 was unanimously approved by a vote of 15-0.

#### VII. CONTRACTS/AWARDS

Resolution 2023-33

Consideration of a Resolution Authorizing the Selection of Qualified Firms and the Awarding Of Contracts for Architectural and Engineering On Call Services.

Mr. Duffy stated that the Authority advertised a Request for Qualifications for architectural and engineering services, civil and mechanical, electrical and plumbing (MEP) last February in order to establish a short list of pre-qualified firms for various upcoming projects. He noted that a pre-qualification meeting was held on March 7 via Zoom and was attended by thirty-six firms. He said that thirty firms submitted proposals and an evaluation committee was established to review and rank the proposals and presentations based on the criteria established in the RFQ. He explained that the Committee's findings were reviewed with management and legal; and six firms were selected in each of the three disciplines (architecture, civil, and mechanical, electrical and plumbing). He explained that the selected firms were listed in the Resolution and would qualify for future work based on proposals submitted using the Task Order Solicitation Process presented in the RFQ.

Commissioner Plofker asked how staff selects from the six qualified firms. Mr. Duffy responded that staff could select randomly, they could select in number order, or they could select all six but it would be a minimum of three.

Commissioner Gordon asked how often these types of firms were selected. Mr. Duffy responded that it would be every four years and that this was the first time this has been done.

Commissioner Schaffer asked Mr. Duffy how past contracts were awarded? Mr. Duffy replied that it was done through a RFP process. He said the projects were publicly advertised, if it were over \$44,000.00.

Chairman Ballantyne presented Resolution 2023-33. Upon motion by Commissioner Plofker and seconded by Commissioner Scardino Resolution 2023-33 was unanimously approved by a vote of 14-0, with Vice Chairman Buckelew abstaining.

#### Resolution 2023-34

Consideration of a Resolution Authorizing the President and CEO to Execute a Change Order to the Contract with Joseph M. Sanzari, Inc. of New Jersey for Deck Repairs of the Bridge over State Route 120, NJ#4900-002 in East Rutherford, New Jersey.

Mr. Duffy explained that a unit-based contract was awarded to Joseph M. Sanzari last spring for the North Connector bridge deck repairs for the plans prepared by French and Parrello following NJDOT guidelines. He stated that the bid included unit-based pricing for various types of repairs as per NJDOT guidelines. He explained that PS&S was hired by the Authority to perform full-time engineering inspection services allowing them to review and approve any additional work along with Authority staff. He said that the proposal for additional work in quantities was reviewed and approved by both the engineering staff of NJSEA and PS&S. He noted that the final quantities were attached to the Resolution and reflected a change order request to the contract for \$259,850.00.

Chairman Ballantyne presented Resolution 2023-34. Upon motion by Commissioner Stellato and seconded by Commissioner Dowd, Resolution 2023-34 was unanimously approved by a vote of 14-0, with Vice Chairman Buckelew abstaining.

#### VIII. PUBLIC PARTICIPATION

Don Smith, Gloversville, New York. Mr. Smith made the following comments:

- He referred to his comment from a previous board meeting regarding what he called an assault on the wetlands located to the right and left along Valley Brook Avenue on the Russo property. He commented that the area had been mowed and then sprayed and now the area was starting to turn green again and the cattails were coming back. He commented that the whole center of the channel on the west side was heavily filled with millet grass, which is an important wildlife food and a primary part of the wetland along Valley Brook Avenue as it receives road runoff and the millet grass claims the water before the pollutants get to the tidal channels to go out to the river. He commented that before anything like that takes place again, it should be required that anyone in the District looking to do this should have come to the Authority to discuss it. He commented that the Authority could then issue a permit, depending on the situation and the timing during the year, which was important. He said he wished the Authority would take this under consideration.
- He referred to the pond located in the middle of the Meadowlands Racetrack, which he
  described as a mud hole. He suggested planting hibiscus, which he stated was a native
  wetland flower that requires no maintenance or fertilizer. He said it could be planted all
  around the pond and it would not interfere with the racing. He said that he hoped the
  Authority would take this under consideration.
- He commented on the Portal Bridge project and questioned if there was a possibility that flood gates could be installed there to stop big storms affecting the District such as the Sandy storm. He commented that if the new bridge couldn't do it possibly the old bridge could be retrofitted with the floodgates, which would only be engaged for a few hours a year but could stop a lot of economic damage and inconvenience to the District. He asked that the Authority look into this.
- He commented that the Authority was sitting on prime property that he feels could be used
  for wetland mitigation. He commented that it could bring in anywhere from zero to \$7
  million dollars. He said that he would be happy to come in by invitation to sit down with
  members of the Board or staff and discuss the possibilities. He thanked the Board for their
  time.

Chairman Ballantyne noted that staff had been in contact with the engineering firm regarding the Portal Bridge and the recommendation of floodgates in that area. He noted staff had also looked into the issue of the spraying of the milkweed. He said that the Board welcomed Mr. Smith anytime to interact with the staff.

Mr. Marvin Donadic, Cliffside Park, NJ made the following comments:

- He commented on the proposed NY Giants logo that was being planned for the middle of
  the field for the upcoming season. He asked if there was anything that could be done to
  mitigate that. President Prieto responded by saying that the NJSEA doesn't have a say on
  their day-to-day operations. He noted that both the Giants and MetLife are tenants of the
  Authority and that was not part of the Authority's lease.
- Mr. Donadic commented that he was a little befuddled that the NJSEA could bring the World Cup to MetLife Stadium but could not take the logo off the field.
- Mr. Donadic commented that two months ago he had touched upon the sensitive subject of race and gender and at that time he asked the two members of the Board to not simply rubberstamp things. He commented that this month he wanted to appeal to the Jewish members of the Board and would like them to know that they have a proud history of accomplishment and that they have been exploited throughout the centuries. He said that he would like to appeal to the Jewish board members to not take nonsense from anyone and if they have a good idea and they wanted to see it implemented, they should do whatever it is they think is right.
- Mr. Donadic wished President Prieto and the Board well. He said he was passionate about New Jersey and will continue to be passionate about New Jersey. President Prieto addressed Mr. Donadic by pointing out that he was the first Hispanic to sit on this Board. He said that there was not a Commissioner on the Board that was a rubber stamp. He said that he was very proud to sit among all these individuals that come from different walks of life.

Chairman Ballantyne echoed President Prieto's comments stating that there was not a member of the Board that was there to rubber stamp anything. He stated that each member of the Board was a volunteer and they were not compensated. He said that they did this as a dedication to the State of New Jersey, to be part of their community and to make sure they protected the Meadowlands District.

James Cassella, East Rutherford, NJ (former Mayor and HMMC Executive Director) He said that he was here as a friend. He said that he was surprised to hear Marylee Vignola was leaving. He commented that she was the one constant at the NJSEA, while the President and CEO have changed over the years, she has always been there. He said that he appreciated everything that she has done for him as Mayor. He said she had always been courteous and he could not say anything negative about her. He wished her the best. He noted that he first met President Prieto when he was an Assemblyman and also when he was the construction official in Secaucus. He said Prieto was very helpful to him when he was the construction official and he said he has always been appreciative of the time he took to assist him. He said that Prieto had always been courteous through his years as Speaker and President at NJSEA. He thanked Prieto for all that he had done for him.

The Board members made the following remarks acknowledging President Prieto and Marylee Vignola's retirements:

Vice Chairman Buckelew stated that he appreciated everything Prieto had done over the years. He noted that he has been with the Board for twenty-two years and said that during that time Vignola was always the ultimate professional, she's cheerful, intelligent, and smart.

He said she did a great job for the Board and that everyone was going to miss her. He wished her the very best in her retirement.

Commissioner Scardino commented that it was like *déjà vu* for him as it was 25 years ago today that he had sat in this same room and people were saying farewell to him as the Executive Director of the HMDC; so he knew how Prieto was feeling today and the anticipation he must have for his future. He said that Prieto's life story was so impressive; to come to this country with your mother on the Freedom Run at the age of 10, not speaking a word of English - and the rest was history. He mentioned Prieto's legislative achievements as an Assemblyman and then as the Speaker. He specifically noted the Transportation Funding Act. He noted that it was fifty years ago, when he was in the Senate, and it was from that time up until Prieto that legislators tried to do something to fund the Transportation Act and it was Prieto that got it done. He also mentioned the legislation that merged the NJMC and the NJSEA. He said that, in and of itself, was a monumental achievement. He said he wished Prieto nothing but the best, to his wife Marlene, his children and his three grandchildren. He addressed Marylee Vignola and said "thanks for just being you, and who you are and for how you have always been there for me and all the Commissioners". He advised Vignola she was going to be missed and thanked her for everything she had done for him personally. He then acknowledged Frank Leanza and said that one of Leanza's attributes is that whenever you asked him his opinion he told you and it is always visible, it's on the table and in some cases to the point where he may have gotten in trouble a few times from the powers that be but in spite of that he still gave his opinion. He thanked Leanza for allowing him to call him a friend.

President Prieto took the opportunity to thank Commissioner Scardino for his kind words, which he said brought back many memories. He stated that the Transportation Fund was his marquee piece of legislation. He said it took him two years to get everyone on board, both Republicans and Democrats. He thanked Chairman Ballantyne for his kind words and resolution, he thanked Vice Chairman Buckelew for his kind words, his wisdom and guidance. He then talked about the agency and the great people that he sits with on the dais, whom he said each bring a unique skill set to the Board. He thanked them for all their support over the years. He commented that all that doesn't happen without the great staff at the Authority. He specifically thanked Christine Sanz, Adam Levy, Beverly Schmidt, John Duffy, Sara Sundell, Terry Doss, Dr. Artigas, and Anna Acanfora. He pointed out Paul Juliano, whom he said was getting the keys to the Agency. He said that he was a good friend that he has known for 30 years and that the Agency was in good hands. He mentioned Monica Mianecki who now leads the Solid Waste Division. He recognized Marylee Vignola and said she meant the world to him. He thanked Steve Cattuna, his former chief of staff, who now heads the Plan Review division. He said he was a great person, a great friend. He commented, last but not least, Frank Leanza, who he said was one of his best friends. He said he was an amazing man with an amazing life. Great father, great husband. He said it had been a joy to work with her and he was going to miss her terribly. He wished Vignola and her family good health, good luck and happiness ahead.

#### **RESOLUTION 2023-38**

### RESOLUTION AUTHORIZING A CONTRACT WITH TRIUMVIRATE ENVIRONMENTAL, HEALTH & SAFETY EXPERTS FOR HYDROGEN SULFIDE MONITORING SERVICES AT THE KEEGAN LANDFILL

WHEREAS, the New Jersey Sports and Exposition Authority (NJSEA) is required to perform hydrogen sulfide monitoring at the Keegan Landfill pursuant to the Administrative Consent Order between the New Jersey Department of Environmental Protection (NJDEP) and the NJSEA dated March 22, 2019 (ACO); and

WHEREAS, on April 16, 2019, on an emergent basis, the NJSEA authorized entering into a contract with Emilcott Environmental, Health & Safety Experts (Emilcott) to install monitors and provide hydrogen sulfide monitoring services at the Keegan Landfill; and

WHEREAS, in 2021, Emilcott was acquired by Triumvirate Environmental, a company that has been providing professional environmental, health, safety and waste management solutions to world-renowned companies for more than 30 years (together, hereinafter referred to as "Triumvirate"); and

WHEREAS, the customized monitor installation and the associated real-time monitoring services were specifically designed and installed around the perimeter of the Keegan Landfill by Triumvirate to meet the unique requirements imposed by the ACO and related NJDEP approvals; and

WHEREAS, the NJSEA remains subject to the requirements of the ACO to provide such monitors and monitoring services at the Keegan Landfill and the installation continues to be successfully monitored and maintained by Triumvirate/Emilcott; and

**WHEREAS**, the term of the agreement with Triumvirate will expire on October 28, 2023; and

**WHEREAS**, the NJSEA desires to renew the agreement with Triumvirate to ensure that the existing equipment, custom installation, and monitoring services continue uninterrupted as required by the ACO; and

**WHEREAS**, Triumvirate has agreed to continue providing equipment and services at an annual rate of \$243,000 for a two-year term total of \$486,000, which is below the current contract of \$525,000; and

WHEREAS, so that NJSEA remains in compliance with regulatory requirements and that monitoring remains uninterrupted and continuous, the NJSEA has determined that Triumvirate should continue to provide the required equipment and monitoring services in the manner set forth by NJDEP in accordance with the ACO; and

WHEREAS, the NJSEA has determined that awarding of this contract to Triumvirate is in accordance with Executive Order 37 (Corzine), which provides for sole source awards where there is only one vendor capable or available to provide the goods or services and N.J.S.A. 5:10-21.4a, which provides that when standardization of equipment and interchangeability of parts is in the public interest, contracts may be negotiated without advertisement for bids.

**NOW, THEREFORE, BE IT RESOLVED**, that the NJSEA is hereby authorized to appropriate \$486,000 for hydrogen sulfide monitoring services and equipment and to contract with Triumvirate Environmental for such services and equipment for an additional period of 24 months.
