The Work of this Contract generally consists of providing all labor, equipment, materials, tools, and services necessary to complete the following: reconstruct portions of the Kingsland Overlook trail with the use of a permeable paver soil stabilization system; replacement of timber walls with modular block walls; construction of new modular block walls; regrade/reconstruct steps; remove, regrade and reset concrete pavers within the Shorewalk Trail; and, installation of PVC pipe for irrigation. The Contract Time is 75 consecutive calendar days from the start date in the Notice-to- Proceed letter.

A bid deposit, in the amount of five percent of the bid, but not exceeding \$20,000 must accompany the Bid.

The Contract Documents contain specific requirements for submission of a bid. No Contractor may bid on the Work of this Contract unless he/she is registered pursuant to this act at the time the bid is made. No Contractor shall list a subcontractor in the Bid for the Work of this Contract unless the subcontractor is registered pursuant to this Act at the time the bid is made.

In order to insulate the award of state contracts from the risk of improper influence, the NJSEA shall only enter into a Contract with a Bidder who complies with Public Law 2005, C. 51 and Executive Order 117.
