Responses to Questions:

Question 1

We would like to know where does Freddie fit into the scheduling, would he be considered a parttime, full time or floater?

As discussed during the bid walk and on the zoom call on the 29th and presented in the bid document SC-475-R-1, on pages 67 and 68 there are two full time cleaners in the Arena day to day for the NJSEA.

The other 'part-time' up to four (4) cleaners (item D on page 68) are not permanent and are utilized at the discretion of the lease holder based on their operational needs. The NJSEA does not know if any of the up to four cleaners will or will not meet the hour's necessary to be considered full time. As was discussed in detail, it all depends on the duration of the leases, their operations and their COVID health protocols.

As was covered on the zoom call, the hours necessary to earn full time benefits under the agreement with the local 108 may or may not be met by one or all of the part time cleaners. It is simply a function of the lease holders operations and the number of days the building is leased out each year.

That said, the hours for the marketplace and train station will basically remain as presented on page 68 items E and F; 30 days for the train station operation and approximately 45 for the marketplace.

Question 2

What is the \$14,000 allotted for in the equipment? It seems a little low considering a walk behind scrubber can cost \$14,000 by itself.

The bid package presents on page 63 the basic equipment expected as part of the \$14,000 equipment expense. Then on page 71 a list of typical equipment that the bidder expects to supply on a regular basis is requested.

Presently the NJSEA utilizes a vendor supplied floor scrubber on a part time basis thus the vendor provides a scrubber as well as other specialty equipment on an as needed basis. Also the NJSEA owns a scrubber that is used in the maintenance facilities.

Question 3

Are the line items for management fee the same number from Page 67 and Page 70?

Yes, Page 70's value should match the total management fee on Page 67. Page 70 is the breakdown of that management fee.
