ADDENDUM #1

RFI Questions

1. Question: When must all work be completed by?

Response: All work must be completed by late March or early April at the latest to be ready for Stadium Event traffic.

2. Question: Which lanes require work?

Response: All lanes on either side of the bridge must be repaired if necessary. Please note one lane on either side must remain open for traffic during the entire duration of work.

3. Question: For Items 8, 9 & 10, *Elastomeric Joint Assembly Items*, Can the Quantities of work to be performed be verified for each item?

Response: Item $8-1\,\%''$ BY 2" PREFORMED ELASTOMERIC JOINT ASSEMBLY entirely replaces the existing elastomeric joint assemblies between each approach slab the abutment header, at each approach. The as-built length of the joint, from inside face of parapet to inside face of parapet, is 100 linear feet.

Item $9 - 2 \frac{1}{2}$ BY 2 $\frac{3}{4}$ PREFORMED ELASTOMERIC JOINT ASSEMBLY entirely replaces the existing elastomeric joint assembly at them midspan transverse deck joint. The as-built length of the joint, from inside face of parapet to inside face of parapet, is 100 linear feet.

Item 10 - 4" BY 4 3/4" PREFORMED ELASTOMERIC JOINT ASSEMBLY entirely replaces the existing elastomeric joint assemblies between the bridge deck and the abutment header, at each end of the bridge. The as-built length of the joint, from inside face of parapet to inside face of parapet, is 100 linear feet.

4. Question: For Item 7, *Deck Joint Repair*, will a new structural steel armored joint be required and should be included for this item?

Response: A new structural steel armored joint will be required, as directed by the RE, in accordance with subpart 506.03.06 of the Special Provisions, and shall be included in the linear foot unit price bid for the item STEEL DECK JOINT REPAIR.

5. Question: For Items 8, 9 & 10, Elastomeric Joint Assembly Items, in all cases does a new block out have to be constructed and are both sides of the block out to be paid for in the per LF Unit Price? Response: A new block out shall be constructed as directed by the RE. The limits of removal and block out reconstruction shall be as directed by the RE and in accordance with the NJDOT Bridge Deck Rehabilitation Deck Joint Repair details (please see sheets 9 and 10). All costs thereof shall be included in the linear foot price bid for the various joint items included in the proposal.

Replacement of any damaged steel deck joint armoring as directed by the RE shall be paid for under the item STEEL DECK JOINT REPAIR.

6. Question: Can the Bid due date be extended by several days, most vendor services will be closed due to the *Seasonal Holiday Period* and will reopen for normal business on January 3, 2023? Response: The bid due date will be extended to January 10, 2023 at 12:00PM.

Bid Walk Notes

Below are notes covered during the bid walk:

- The bid sheet and advertisement included an error in the bid due dates- The correct due date is January 10th, 2023 and an updated version of these pages have been attached for your submission. **NOTE: You MUST submit the updated set of pages in the Specifications with the correct date, or your submission will be invalid. **
- 2. The following dates must be adhered to be considered for award:
 - a. December 16th, 2022 at 3:00M All questions and concerns must be submitted
 - b. January 10th, 2023 at 12:00PM All bids must be delivered to One Dekorte Park Plaza Lyndhurst, NJ, 07071 (hand delivered or mailed)
- 3. As discussed at the bid walk, existing potholes will be filled with asphalt mix to make them safe throughout the winter. Please plan on removing the mix as part of your repairs during your work.
- 4. An allowance for the South Bridge repairs may be added to the project. NJSEA to advise with more information.
- 5. In Section 00010 "Advertisement for Bids," the contract time states 120 days from the start date given. For clarification, the *work itself* must be completed within 30 days of the start of work, as stated in the "Scope of work."
- 6. The schedule of bid prices has been updated to reflect changes in estimated quantities. On the attached document, the page describes the small changes made to the quantities in the schedule of bid prices that we reissued in the updated specifications. **NOTE: You MUST submit the updated schedule of bid with the corrected quantities, or your submission will be invalid. **
- 7. For clarification and ease of reference, a list is shown below of anticipated submittals but is not intended to be all inclusive. The respective subsection of the NJDOT Standard Specifications or Special Provisions is included for reference.
 The necessary submittals may not be explicitly listed in Table 105.05-1 of either document.

Please note that the NJDOT Standard Specifications are incorporated by reference into the project's Special Provisions. In general, the Contractor must submit methods of construction, material designations, design calculations, catalogue cuts, illustrations, schedules, performance charts, brochures, and other information necessary to construct the work as specified in the Contract and to perform the work to the satisfaction of the NJSEA.
