BIDS WANTED FOR MEADOWLANDS BRIDGE DECK REPAIRS/CN-277

The New Jersey Sports and Exposition Authority (NJSEA) is seeking bids for a contractor experienced in bridge deck repair work for the New Jersey bridge over State Route 120, NJ#4900-002. The location is the New Jersey Sports & Exposition Authority NJSEA Meadowlands bridge over State Route 120, NJ#4900-002 and will comprise of a bridge deck repair as specified in the bid. The term of this contract is for a one hundred and twenty (120) day period.

Documents for the bid work will be available for download from our website at www.njsea.com beginning on November 29th, 2022 at 2:00 p.m.

A mandatory pre-bid meeting is scheduled for Tuesday, December 6th, 2022, at 10:00 AM at the NJSEA Meadowlands Arena Employee Entrance (North entrance between Gates B & C across from Lot 27), followed by a project site visit at bridge NJ#4900-002. All perspective bidders must register by emailing njseabids@njsea.com due to COVID safety requirements. A maximum of two people from each bidding firm may attend and strict COVID safety protocols are to be adhered to at all times.

Any firm attending the bid walk must meet the outlined requirements in the bid documents. All firms who attend the bid walk must submit all questions and concerns by Friday, December 16th, 2022 at 3:00 PM.

Bids will be received at the Administration Building at 1 DeKorte Park Plaza, Lyndhurst, NJ until 12:00 PM, prevailing time, on January 3rd, 2022. Bids will not be accepted after the above time and date.

In accordance with Public Law 2004, c.57, the NJSEA may only enter into contracts with Bidders who provide proof of valid business registration with the Division of Revenue in the Department of Treasury, of the State of New Jersey. Such proof must be submitted concurrently with the bid.

In order to insulate the award of state contracts from risk of improper influence, the NJSEA shall only enter into a Contract with a Bidder who complies with Public Law 2005, C.51, Executive Order 117, and Public Law 2022, c.3. The required forms and instructions are included in the bid.

NJSEA reserves the right to reject any and all bids and, so far as permitted by law, to waive any irregularity or informality with respect to any bid. The NJSEA further reserves the right to make such investigations as it deems necessary as to the qualifications of any and all firms submitting bids. In the event that all bids are rejected, the NJSEA reserves the right to re-solicit bids.

Equal Employment Opportunities Requirement - Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27.
