The New Jersey Sports and Exposition Authority (NJSEA) is currently seeking proposals from qualified entities authorized to do business in the State of New Jersey to assist NJSEA to develop the Meadowlands Action Plan for Safety (MAP4S) as follows:

MEADOWLANDS ACTION PLAN FOR SAFETY - MAP4S

Notice is hereby given that all Proposals shall be submitted electronically to map4s@njsea.com. The Proposal and Proposal Forms contained in Section 2 of the Request for Proposal (RFP) package must be submitted electronically to map4s@njsea.com no later than 5:00 p.m. on **November 20, 2023**. Proposals will NOT be accepted after the aforementioned date and time.

With a goal to promote safe and equitable transportation within the Hackensack Meadowlands District, the NJSEA has secured a Federal grant to develop the District's first Safety Action Plan. In developing the Meadowlands Action Plan for Safety (MAP4S), the consultant team shall assist in establishing a Safety Task Force, develop a comprehensive community outreach program, study and analyze crashes within the District, develop safety improvement projects, define metrics and develop a methodology to prioritize safety improvement projects, recommend safety policy changes to reduce crashes and promote a Vision Zero initiative, and develop a safety tool to assist locals to analyze safety needs, prioritize safety projects, and assess the effectiveness of deployed/constructed safety projects. The MAP4S will provide a robust plan for constituent municipalities within the District to establish a systematic and proactive safety plan to promote a Vision Zero initiative.
