BIDS WANTED FOR ARENA WINNERS DOOR AND STOREFRONT REPLACEMENT/CN-284

The New Jersey Sports and Exposition Authority (NJSEA) is seeking bids for a contractor experienced in Storefront Doors replacement for the Meadowlands Arena Winners Club/ State Police Entrance. The location is the New Jersey Sports & Exposition Authority NJSEA Meadowlands Arena and will comprise of a door and storefront replacement as specified in the bid. The term of this contract is for a one hundred and eighty (180) day period.

Documents for the bid walk will be available for download from our website at www.njsea.com beginning on November 15th at 2:00 p.m.

A mandatory pre-bid walk is scheduled for Tuesday, November 28th, 2023, at 10:00 AM at the New Jersey Sports & Exposition Authority NJSEA Meadowlands Arena Winners Club/ State Police Entrance (East entrance between Gates C & D). All perspective bidders must register by emailing njseabids@njsea.com.

Any firm attending the bid walk must meet the outlined requirements in the bid documents. All firms who attend the bid walk must submit all questions and concerns by Tuesday, December 12th, 2023 at 3:00 PM.

Bids will be received at the Administration Building at 1 DeKorte Park Plaza, Lyndhurst, NJ until 12:00 PM, prevailing time, on December 19th, 2023. Bids will not be accepted after the above time and date.

In accordance with Public Law 2004, c.57, the NJSEA may only enter into contracts with Bidders who provide proof of valid business registration with the Division of Revenue in the Department of Treasury, of the State of New Jersey. Such proof must be submitted concurrently with the bid.

NJSEA reserves the right to reject any and all bids and, so far as permitted by law, to waive any irregularity or informality with respect to any bid. The NJSEA further reserves the right to make such investigations as it deems necessary as to the qualifications of any and all firms submitting bids. In the event that all bids are rejected, the NJSEA reserves the right to re-solicit bids.
