The NJSEA website should be consulted prior to the meeting for verification of Meeting ID.

Video functionality will only be turned on for NJSEA Staff and the NJSEA’s Consultant as needed. The NJSEA’s designated “Host” will guide public comment portions on the Zoom platform. If you are a member of the public and wish to participate in the public portions of the meeting, you must follow these instructions to join the virtual meeting via Zoom or the audio portion of this meeting:

1. Join the meeting using the Zoom computer application or telephone information provided above.
2. All microphones of the public will be muted except during the public comment portions of the meeting.

3. During the public comment portions of the meeting, participants who would like to speak can “raise their hand” by tapping the icon  in Zoom. If participating by telephone, members of the public can raise their hand by pressing \* 9.
4. Public participants may also use the “Chat” function to send typewritten messages to the “Host” including their first and last name, address or their affiliations (if they are representatives of organizations/firms/agencies) indicating that they would like to make comments/questions during the public portions of the meeting.
5. During the public comment portions of the meeting, the host will announce the name of the next member of the public to speak and unmute that person’s microphone, at which time, the member of the public may address the NJSEA Staff. Members of the public will have the capability to participate via audio only.
6. Members of the public will be required to identify themselves by stating their full name, and address or their affiliation, when they are invited to speak. The host will mute the public speaker’s audio after they have completed their comment(s) and/or question(s).
7. Alternatively, public participants may use the “Chat” box to state/ask their comments/questions after declaring their first and last name, address or their affiliations (if they are representatives of organizations/firms/agencies).
8. All comments and/or questions made during the meeting will be recorded.

As circumstances dictate, it is possible that the procedures described herein will be modified as required to ensure appropriate access to the meeting.
